Sub :- Prayer for lodging specific case, as per proper section of law.

Sir,

In producing herewith the seized vehicle, viz, WB87/0593, (16-wheeler Truck); I beg to state that, I PSI Akash Patra of Bishnupur PS along with force were performing Jungle Night mobile duty in the PS area vide Bishnupur PS GDE No 560 dt 09.02.24 and CC No -661/24, Dt- 09.02.24. On 10.02.24 at 02.45 hrs received information from table duty officer LSI Swasati Maitty of Bishnupur PS to the effect that one accident took place near the Dwarika Vasabi factory, on Bishnupur -Sonamukhi pith road. I informed the same to IC Bishnupur PS and moved to the accidental spot.

On arrival at the spot near the Dwarika Vasabi factory, we found a brick-loaded truck with registration number WB87/0593 standing in the middle of the Kananadi Bridge on the Bishnupur – Sonamukhi bound pith road. The front portion of the truck was in damaged condition. The driver and helper of the vehicle received injuries and therefore shifted to Bishnupur District Hospital for treatment. On interrogation and local enquiry, it is learnt that the Truck was coming towards Bishnupur side from Sonamukhi side, and dashed one road-side vehicle bearing no- WB39A/4996 (10wheeler), from back side. The Truck bearing Regi no- WB87/0593 also dashed one Electric pole there, and damaged it also. As a result, the vehicle which was already parked there damaged badly and due to the collision, fall down on road side ground. The incident occurred due to rash and negligent driving of the driver of the Truck bearing Regi no- WB87/0593.

In these circumstances I submitted a *suo moto* complaint as first information report before you to take necessary action against the driver of the Truck, bearing Reg No WB87/0593.
