Sub:- Prayer for starting a specific case.

Sir,

In producing here with one arrested accused person namely Rajesh Dhara (25yrs), S/O- Naran Dhara of Vill-Nandur, PO- Akhrasole, PS-Patrasayer, Dist-Bankura and seized one Tractor bearing registration no WB 88G/9130 along with sand loaded trolley, and one Road E-Challan for Sand, vide E-Challan No. 7510151/S/23-24/261220233523/PS, issue date 18.02.24, as per proper seizure list; I ASI Pankaj Patra of Radhanagar O.P. under Bishnupur P.S., do here by lodge this complaint that today (18.02.24) morning at about 11.00 hrs. during my patrolling duty, vide Radhanagar Out Post C.C. No-100/24 date-18.02.24, and Radhanagar Out Post under Bishnupur PS GDE No- 445 Date-18.02.24, was engaged in checking of sand or other minerals loaded vehicle through WBMDTCL app, as per order of superiors, from different strategic points. At about 12.15hrs, near Dangar para village, I stopped the aforesaid number sand loaded Tractor, which was coming towards Hingjuri side from Joykrishnapur side.

On asking the driver of the Tractor, namely Rajesh Dhara S/o-Naran Dhara of vill- Nandur, PS-Patrasayer, Dist- Bankura, produced one Road E-Challan in respect of the loaded sand, vide E-Challan No- 7510151/S/23-24/261220233523/PS, issue date 18.02.24. I verified the E-Challan through WBMDTCL(Sand) application by scanning the QR code from my android mobile phone and it is found that this E-Challan is Expired, not only that, the issue date was noticed as 26.12.23. The driver often gave incoherent statements as sometimes stated that he loaded the sand from Jujur Bali Ghat and sometimes stated that loaded the sand Dwarekeswar river from illegal sand ghat, and this E-Challan has been supplied to him by the owner of the Tractor namely Swarup Dhara for transporting the sand. Thus, the driver and owner of the Tractor are stealing the sand and transporting & selling the same illegally and by fraudulently editing E-Challan for sand, without paying any revenue to the Government.

After that, I arrested the driver of Tractor namely Rajesh Dhara (25yrs), S/O-Naran Dhara of Vill-Nandur, PO-Akhrasole, PS-Patrasayer, Dist-Bankura and informed him regarding his ground of arrest and issued Memo of arrest after maintaining all legal formalities. I also seized the Tractor bearing Reg. No- WB88G/9130 loaded with sand in Trolley amounting about 100 (one hundred) Cft., and the E-Challan bearing No. 7510151/S/23-24/261220233523/PS, Issue date 18.02.24 under proper seizure list from the above noted driver, as duly signed by him and witnesses in between 13.35 hrs and 14.05 hrs.

Under the above fact & circumstances it is evidently established that the accused driver namely Rajesh Dhara (25 yrs), S/O- Naran Dhara of Vill-Nandur, PO- Akhrasole, PS-Patrasayer, Dist-Bankura and owner of the Tractor have been stealing the sand and transporting & selling the same illegally, by fraudulently, as well as using and making forged E-Challan. Therefore, I pray that specific case may kindly be started under proper section of law against them and oblige.
