Sub: Complaint against drivers Santosh Ghosh (22y) s/o- Pradip Ghosh of Chhatarkanali, PO- Tiluri, PS- Saltora, Dist Bankura driver of the sand loaded tractor bearing Regd No- WB68AL-8526 & Babujan Hansda (20y) s/o- Lt Mansingh Hansda of Balarampur, PO- Tiluri, PS- Saltora, Dist Bankura driver of the sand loaded tractor bearing Regd No-WB81-2393 and owners of the above noted vehicles.

Sir,

In producing herewith seized sand loaded tractor bearing Regd No- WB68AL-8526 & WB81-2393 loaded with illegal sand along with seizure list., I SI Animesh Char In-Charge of Jhantipahari OP U/Chhatna PS, do here by lodge a typed complaint to the effect that in the on 19.02.2024/20.02.2024 night myself along with force were visiting my OP area (vide Jhantipahari OP C.C. No. 72/24 dated 19.02.2024 and Jhantipahari OP GDE No. 434 dated 19.02.2024 u/Chhatna PS, Bankura). In the course of my night visit in Jhantipahari OP area at about 04.00 hrs received information that in regular courses some tractors are transporting sand illegally from Chhatarkanali area of Damodar River under Saltora PS. And they are selling sand in the Manihara village side under Dhaban GP. Accordingly, the myself along with my police team placed a naka near Bhelani Primary School morh on Bhelani - Lapahari road. Some times after we found two tractors are coming towards Bhelani then somehow we managed to intercept two tractors and found that those tractors bearing Regd No- WB81-2393 & WB68AL- 8526 fitted with a trolley which is loaded with sand. Then I asked the driver of the said sand loaded tractor bearing Regd No-WB68AL-8526 namely Santosh Ghosh (22y) s/o- Pradip Ghosh of Chhatarkanali, PO- Tiluri, PS- Saltora, Dist Bankura & another sand loaded tractor bearing Regd No-WB81-2393 namely Babujan Hansda (20y) s/o- Lt Mansingh Hansda of Balarampur, PO- Tiluri, PS- Saltora, Dist Bankura and they stated that they are illegally extracted sand from the river of Damodar at Chhatarkanali area under Saltora PS and transporting the same to another place to get their illegal gain. On being asked they also stated that they are carrying sand without any valid carrying order or Challan. During interrogation it also found that in regular courses they are mining sand illegally from Chhatarkanali river ghat of Damodar River under Saltora PS and illegally transporting said sand in the Chhatna, Saltora PS area in the dark night and behind that the owner of the tractors also involved in this illegal activity.

Under this circumstance it is strongly believe that the quantities of sand were extracted from Chhatarkanali river ghat of Damodar River under Saltora PS with the help labors illegally. Also know that they are carrying and loading sand without any valid carrying order or challan. It is also believe that the owners of the vehicles are also involved in this illegal racket as they engaged their respective vehicles for such illegal act. And they involved in this illegal activities in day by day as habitual manner.

Therefore I seized both the sand loaded tractor bearing Regd No- WB68AL-8526 & WB81-2393 fitted with trolley which is loaded with sand as per proper seizure list dully signed by the said drivers and the police witnesses as no such local peoples were there at that time. Accordingly, I arrested the driver of the said sand loaded tractorone namely Santosh Ghosh (22y) s/o- Pradip Ghosh of Chhatarkanali, PO- Tiluri, PS-Saltora, Dist Bankura driver of the sand loaded tractor bearing Regd No- WB68AL-8526 & another one Babujan Hansda (20y) s/o- Lt Mansingh Hansda of Balarampur, PO- Tiluri, PS- Saltora, Dist Bankura driver of the sand loaded tractor bearing Regd No-WB81-2393 under maintaining all legal formalities of arrest and inform their family also regarding their detention.

Therefore I submitted a typed complaint before you to start a specific case against the above noted drivers & owners of the sand loaded tractor bearing Regd No- WB81-2393 & WB68AL-8526 under proper section of law.
