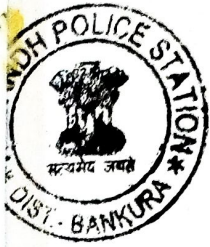

Sub: - Prayer for lodging F.I.R under proper section of law.

Respected Sir,

In producing herewith one (01) tractor having bearing no- Tractor bearing no- WB-68X/4688, Engg No- 43.3008/SYN35850, Chassis No- WSCN40922185914 style as Swaraj (Mahindra & Mahindra Ltd.), with white-blue colour trolley bearing Trolley No- WB-39 TA/5584 loaded with sand under proper seizure list duly signed by the witnesses. I beg to inform you that on 19.02.2024 at about 06:25 hrs I received an information from reliable source in course of P.S mobile duty (Hirbandh PS GDE No- 779 Dated 18.02.2024 & Hirbandh P.S C.C No- 437/2024 Dated 18.02.2024) that a sand loaded tractor having bearing no- WB-68X/4688 style as Swaraj (Mahindra & Mahindra Ltd.) with white-blue colour trolley which is involved in illegal sand transportation without having any proper challan or valid document is coming from Indpur PS side towards Hatirampur More side. I informed the matter accordingly and as per order of OC Hirbandh P.S, I along with force went towards Baharamuri village near Baharamuri Primary School under Hirbandh P.S to intercept the sand loaded tractor. At about 07:05 hrs we found that the above noted tractor having bearing no- WB-68X/4688 style as Swaraj (Mahindra & Mahindra Ltd.) with white-blue colour trolley loaded with sand was coming from Indpur PS side towards Hatirampur More side. Seeing the Police van from a distance, the driver of the said tractor stopped vehicle by the side of road at Baharamuri village near Baharamuri Primary School and started to flee away leaving behind his vehicle on the road. I along with my accompanying force chased him and somehow could apprehend the driver of the said Tractor.

On being asked, he disclosed his identity as namely Sourav Patra (31 Yrs) S/o- Kanchan Patra of Vill- Kayabaid, PS- Indpur, Dist- Bankura (Driver of the said loaded tractor). On further interrogation, I came to learn that the tractor was loaded from Patirdanga Ghat of Shilabati River under Indpur PS under Bankura district with the help of other one associate but he fled away from the place. On demand, accused driver could not produce any challan or valid documents or could give any satisfactory answer in respect of his Sand loaded in Tractor.

On being search I could not find any papers of the said vehicle over the sand transportation. It is crystal clear that he has loaded sand in his vehicle by any fraudulent means after stealing it from any sand stock point. So, I seized the said vehicle with trolley loaded with sand as per seizure list and arrested the accused driver after maintaining all legal formality of NHRC guidelines of the apex court.


Hence, I pray that a specific case may kindly be started in against him and to take necessary action as per law.
