In producing herewith the arrested persons namely i) Sk Basir Hossain (approx 32 yrs) S/o- Lt. Sk Hossain of vill- Bamunpukur, PS- Khandaghosh, Dist- Purba Bardhaman, ii) Subhasis Roy (Approx 20yrs) S/O- Swarup Roy of Vill-Bamunpukur, PS- Khandaghosh, Dist-Purba Bardhaman and one seized Engine Van loaded with 30 pieces sacks full of sand under proper seizure list duly signed by the accused persons and witnesses. I beg to report that on 06.02.24 at 10:05 hrs while I was engaged in P.S mobile duty vide Indas P.S C.C No- 52/24 dtd. 06.02.24, received information from secret source that one Engine van is coming through the road of Kunjapur to Bamnia side loaded with 30 pieces sacks full of sand without proper papers. Accordingly, after obtaining kind order of OC Indas P.S, myself along with force reached at near Bordanga More under Indas PS area and found the said Engine van is coming from Kunjapur village side and proceeding towards Bamnia side under Indas PS. I somehow managed to apprehend the engine van and asked the driver to produce legal documents. But the driver could not produce any valid documents in respect of sand. On interrogation they confessed that they had no legal documents in respect of the sand, which they have extracted from Dwarakeswar River without having any permission. Finding no other alternative I have seized the said Engine Van loaded with 30 pieces sacks full of sand in-between 11:25 hrs to 11:45 hrs under proper seizure list. I requested the local people to sign in the seizure list but nobody found willing to sign in the seizure list. Accordingly my accompany force signed in the seizure list, and I arrested the accused persons namely i) Sk Basir Hossain (approx 32 yrs) S/O- Lt. Sk Hossain of vill- Bamunpukur, PS- Khandaghosh, Dist- Purba Bardhaman & ii) Subasis Roy (Approx 20yrs) S/O- Swarup Roy of vill-Bamunpukur, PS-Khandaghosh, Dist- Purba Bardhaman in between 12:00 hrs to 12:05 hrs maintaining all legal formalities.

I, therefore, pray before you that a specific case may kindly be started in this regard under proper section of law and arrange for its investigation.
