Sir,

In producing herewith, the two arrested accused persons namely [1] Alauddin Mondal (Approx. 21 Years), S/o- Sainur Ali Mondal of Aguri Bandh, Punisole, PS- Onda, Dist- Bankura, and [2] Kalu Mondal @ Kadar Siddiquie (Approx.-21 Years), S/o- Abdur Rahim Mondal of Asanmoni, Punisole, PS- Onda, Dist- Bankura & one apprehended person namely [1] Tajmul Hossen Mallik (Approx.-17 Years), S/o- Makbul Hossen Mallick of Aguribandh, Punisole, PS- Onda, Dist:- Bankura. Therefore, I also seized (1) One Iron crowbar approx- length 1 feet 10 inch, (2) One iron rod approx length 02 feet 01 inch, (3) G.I. wire approx length 25 meters, (4) One white & black colour chinese rechargeable torch light, (5) One plastic bag containing 06(six) pieces yellow colour Nylon rope approx length 15 meters & 02 (Two) pcs. yellow colour nylon rope length approx-10 feet., (6) One Bhajali approx length 12"(inches) with wooden handle length approx. 04 inch which were seized from the possession of Alauddin Mondal and I also seized (1) One improvised country made small fire arms with barrel, having length 3 ½" approx. iron fitted with wooden butt having length 3 ½", Iron body having length 3"(approx.) fitted with trigger, hammer and firing pin, trigger guard total length approx-10" which was kept in the left waist of accused person namely Kalu Mondal @ Kadar Siddiquie, (2) One round .303 live ammunition which was kept in left side pocket of the wearing pant of accused person namely Kalu Mondal @ Kadar Siddiquie under proper seizure list and label under proper seizure as alamat, I beg to lodge the complaint against the above noted arrested accused persons and 3/4 others, all of their other associates. I beg to inform you that on 22.02.2024 at about 21:55 hrs received secret source information, that a gang of dacoits have assembled at Dharampur jungle area with a view to commit road crime at Dharampur-Gourbazar pitch road. Accordingly, I informed you and as per your kind direction, I SI Jyotilal Mahato of Indpur PS along with force (Vide C.C No- 342/24, dated-22.02.2024 and GDE No: - 783, dated- 22.02.2024) proceeded to work out the information and at about 22:25 hrs reached at Dharampur jungle area under Indpur PS. Leaving our vehicle there, we proceed on foot approx. 500 meters and reached near Dharampur jungle in a concealed manner. There, I found that a whispering was coming out from middle of the jungle. Accordingly, myself along with our accompanying force ambushed there. Subsequently, with the help of my accompanying force surrounded the area to verify the source information. In the darkness of night hours, I found that six-seven persons were sitting there. I could also hear that they are making preparation for committing dacoity on road vehicles. We reached nearest to them and clearly heard their whispering talks which disclosed their plan for committing dacoity on road vehicles by making road blockade & causing fear by showing firearms upon plying vehicles and motor-cycles. Thereafter, from a close distance we disclosing our identity in full uniform commanded them to surrender. It was on 22.02.2024 at about 22:35 hrs night, when instead of surrendering, they started to run for shelter but myself with the help of my accompanying force could manage to apprehend three of them but others managed to escape with the help of darkness of night. On interrogation, they gave incoherent statements at different times. On further interrogation, they disclosed their identity as namely [1] Alauddin Mondal (Approx.-21 Years), S/o- Sainur Ali Mondal of Aguri Bandh, Punisole, PS- Onda, Dist- Bankura, [2] Kalu Mondal @ Kadar Siddiquie (Approx.-21 Years), S/o- Abdur Rahim Mondal of Asanmoni, Punisole, PS-Onda, Dist- Bankura & [3] Tajmul Hossen Mallik (Approx.-17 Years), S/o- Makbul Hossen Mallick of Aguribandh, Punisole, PS- Onda, Dist:- Bankura and also confessed that they assembled there with a view to commit road dacoity there but they did not disclose the identity of their other associates at that time. Subsequently, I along with my accompanying force offered them to search us but they refused. Thereafter, I thoroughly searched them and also the P.O with the help of my accompanying force after arranging sufficient light. Accordingly, the above noted articles were seized from the possession, shown and identified of the accused persons. As it was at night hours, I could not find any public witness at that place. On interrogation the above noted accused persons failed to explain their such conduct for making

assemble at such lonely place armed with deadly weapons and being resident of outside of Indpur PS area. As there was specific information, there was every reason to believe that the team of dacoits had assembled there and were preparing for committing dacoity on road vehicles. Accordingly, I arrested two accused persons namely (1) Alauddin Mondal and (2) Kalu Mondal @ Kadar Siddiquie under proper memo of arrest and also apprehended one person namely Tajmul Hossen Mallik under proper apprehension memo. I supplied a copy of seizure list as well as copy of Memo of Arrest to the arrested accused persons after maintaining all legal formalities and obtaining their signatures. I did not venture to take any public witness with us as we had specific information about the assembled of a gang of the dacoits with deadly weapons.

On my arrival at P.S with the above noted two arrested accused persons and one apprehended person with the seized alamats, I am producing them before you for starting a specific case under proper section of law against all the involved persons are verified to be notorious criminals. Kindly arrange its investigation and oblige.
