Dear sir,

I, Sri Madhab Chandra Kundu, S/O Aditya Kumar Kundu, A.E & Station Manager, Kotulpur Customer Care Centre, WBSEDCL being empowered by Electricity Act 2003 amended in 2007 do hereby lodge a complaint against accused Swapna Digar, S/O-Sudhir Digar of Vill - Nanagar, P.O - Bhagalpur, P.S - Kotulpur, Dist:- Bankura for committing theft of electricity by way of direct hooking from nearby L.T.O.H line by using two nos single core PVC cable for the purpose of his Domestic use.

On getting the source information of theft of electricity myself along with Biswajit Mandal, J.E(Gr-II) & Gautam Kr Dolui, HG-T.S.H of Kotulpur CCC & Sri Biplab Mandi, D.E, S & LP & Sri Sankar Ch Dana, Special Officer, S & LP, Bankura Region Office today 06.02.2024 between 15:15 to 15:35 hours inspected the Domestic premises of accused Swapna Digar, S/O-Sudhir Digar of Vill - Nanagar, P.O - Bhagalpur, P.S -Kotulpur, Dist:- Bankura.

During inspection it was detected that the said accused person was enjoying electricity unauthorizedly by way of direct hooking from nearby L.T.O.H line by using by two nos single core PVC cable for his Domestic purpose use. Thus the accused user Swapna Digar, S/O-Sudhir Digar violated the existing rules of Electricity Act 2003 (amended in 2007).

Inspection report prepared on the spot and assessed consumption of load which was detected as 1500 Watt. The details have mentioned in the Inspection report.

I directed Gautam Kr Dolui, S/O- Lt Probhas Dolui to remove the portion of hooking cable from LTOH Line. Accordingly he disconnected the PVC cables from the L.T.O.H line as per direction. I seized the portion of the hooking cable for preparation of seizure list. I fixed up the responsibility to the accused user, Swapna Digar, S/O-Sudhir Digar of Vill - Nanagar, P.O - Bhagalpur, P.S -Kotulpur, Dist:- Bankura with the help of my source, since the perpetrator was present at the time of my inspection as well as detection of offence.

It is well proved that the said accused person Swapna Digar, S/O-Sudhir Digar of Vill - Nanagar, P.O - Bhagalpur, P.S -Kotulpur, Dist:- Bankura was committing the theft of electricity as he was using electricity unauthorizedly by direct hooking. As such he is liable for persecution U/S 135(1) (a) of Electricity Act 2003 (amended in 2007).

Kindly treat this complaint as F.I.R
