Sub: Prayer for starting FIR against arrested person namely_Saheb Ruidas (35 years) s/o- Kartick Ruidas of vill- Dhabapukur, PS- Kotulpur, Dist- Bankura.

Respected Sir,

With due respect and humble submission I beg to state that I ASI Goutam Mondal of Kotulpur Police Station, District- Bankura do hereby lodge this complaint to the effect that today i.e. on 09.02.2024 at about 18.25 hrs received a telephonic information from duty officer of Kotulpur P.S that one person is preparing & selling I/D Liquor at village Dhabapukur without having any license of competent authority. Accordingly I informed O/C Kotulpur PS and as per order I ASI Goutam Mondal along with my accompanied force namely C/1766 Biswajit Rajak & NVF 0531 Arindam Bhakat all of Kotulpur P.S vide Kotulpur P.S C.C. No. 339/2024 dt. 09.02.2024 & GDE No. 408 dt. 09.02.2024 with proper uniform by Govt. vehicle and with I.O's kit containing white paper, carbon, gala, seal, wax, white markin, Match box, candles etc. While I ASI Goutam Mondal along with accompanied force had been to village Dhabapukur and found from a distance that one person is selling bottles of I/D liquor to his customers at his house. Seeing the Police some persons fled away from house of the accused person. But we could detain the person who was manufacturing & selling I/D liquor to his customers. We gave our identity to him as Police personnel of Kotulpur Police Station and then told him about the information which we had with us. We, the Police personnel offered him to search our persons before we start searching, but he told that he will not search our persons. During search in between 19.15 hrs to 19.35 hrs container full of I/D liquors and manufacturing articles were found from the house premises of said detained person. The description of the ID Liquors and manufacturing articles are given below:

1. Three white colour Plastic Jariken each contained 10 (ten) Litters of I.D. liquor
2. 45 (Forty five) numbers of plastic glasses.
3. Two apparatus and two medium size aluminum Handi

During interrogation the accused disclosed his identity that he is Saheb Ruidas (35 years) s/o- Kartick Ruidas of vill- Dhabapukur, PS- Kotulpur, Dist- Bankura and he also confessed his guilt. On demand he could not produce any valid license of competent authority to manufacturing & sealing of I/D liquor. So I seized the above noted I/D liquors and articles which was found from his possession. Seizure is done under proper seizure list duly signed by the witnesses and I offered local people to sign the seizure list but they are not turned up. I have sealed and labeled the above noted jarikens, pouches, plastic glasses and manufacturing articles. Accordingly I arrested him under maintaining all the legal formalities of N.H.R.C Rules.

I therefore pray that a specific case may kindly be started against Saheb Ruidas (35 years) s/o- Kartick Ruidas of vill- Dhabapukur, PS- Kotulpur, Dist- Bankura for proper investigation as he has committed an offence under the provision of Bengal Excise Act.
