Sub: Prayer for lodging FIR.

Sir,

In producing herewith 01 tractor having bearing Regd no-WB68X/2787 vide Engine No- 43.1024/SYF14447, Chassis No-WSTF40622100832 loaded with sand. I beg to submit that today (25.02.2024 morning) while myself along with C/1853 Rabindra Nayek, C/1820 Tarak Mondal, HG-SRG/41 Karali Mahanti, vide C.C No- 443/23 dt 24.02.2024 was engaged in night mobile duty at Onda P.S. area at that time received source information that one sand loaded tractor was coming from Darakeswar river. As per source information myself along with force were moving towards Santore village from Kalisen on the way on dated 25.02.2024 at about 06:05 hrs and found one tractor bearing regd. no WB 68X/2787 fitted with sand loaded trolley coming from Santore village side. Giving signal to stop the tractor then the driver of the tractor stopped the tractor on road and run away through cultivated field. We trying to apprehended him but could not succeed. We spend so many times there but no one turn up or produce any documents in respect of the said tractor, trolley and loaded sand.

There is sufficient reason to believe that the owner of the tractor bearing Regd No-WB68X/2787 and the driver of the tractor have loaded sand in their tractor by any fraudulent means after stealing from nearest Darakeswar river. Then I seized the said tractor bearing regd. no WB 68X/2787 fitted with sand loaded trolley after preparing proper seizure list duly signed by the witnesses. I asked several local people for witnessed but no one turnup.

Hence, I pray before you kindly started a specific case against the owner & driver of the aforesaid offending tractor bearing no-WB68X/2787 and to take action as per law.
