Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused persons namely 1) Hijajul Khan(M/24 yrs) S/O Karim Khan of Vill-Mohona, P.S- Mejia, Dist- Bankura (Driver of the Dumper) 2)Mahatab Khan(M/21 yrs) S/O-Akhtar Khan of Vill-Mohona, P.S- Mejia, Dist- Bankura (Khalasi of the Dumper) along with seized Dumper (06 Wheeler), bearing regd. no WB37D/8080 Loaded with Sand under proper seizure list ,I ASI Sanjai Kuiry of Saltora PS lodged complainant as suo-moto that on 24.02.2024 at 22.05 hrs during my mobile duty , received an source information, that Sand have been transporting illegally by loading in the Dumper through Pabra to Rampur Pitch road .Then as per direction along with force vide C.C No-645/24 dtd. 24.02.2024 left for Pabra Hattola to work out the information.

On reaching near Pabra Hattola road under Saltora PS at about 22:25 hrs, I found that one Dumper (06 Wheeler) bearing regd. no WB37D/8080 Loaded with Sand was coming from Pabra More to Rampur side.I along with force stopped the said Dumper at Pabra Hattola. Then I asked the above noted driver and Khalasi of the said Dumper to produce valid documents in respect of the Dumper and loaded Sand. But They neither produce any valid documents in support of the Vehicle and loaded Sand respectively nor give any satisfactory answer in this regard which made me to believe that the said person stealing the Sand by fraudulent means and transporting the sand to elsewhere to sell the same. On examination the above noted persons made different statements in different times. Later on, they both admitted that they along with owner of the dumper, bearing Registration No- WB37D/8080 deal with the sand illegally. They both along with the Owner of the said Dumper used to load Sand from the different Sand mines without any valid documents and transported the same by fraudulent means for selling the same. Thus they (Driver & Khalasi) along with owner of the Dumper are stealing the Sand and Transporting and selling the same illegally by fraudulent means without paying any revenue to the Government.

Thereafter, I arrested them both at about 22:35 hrs after maintain all legal formalities and direction of Hon'ble apex Court and maintained the guidelines of NHRC regarding arrest and I Seized the said One Dumper (06 Wheeler), bearing Registration No- WB37D/8080 loaded with the Sand from the possession of above noted arrested accused persons in between 22:45 hrs to 22:55 hrs under proper seizure list duly signed by them and witnesses .So far Source information collected it is raveled that the Owner and driver and Khalasi of the said Dumper used to transport the stolen Sand and conceal those in different place for selling.

Under the above facts and circumstances ,I Pray that a specific case under Proper section of law may kindly be started against the arrested accused Driver namely 1) Hijajul Khan(M/24 yrs) S/O Karim Khan of Vill-Mohona, P.S- Mejia, Dist- Bankura (Driver of the Dumper) 2)Mahatab Khan(M/21 yrs) S/O-Akhtar Khan of Vill-Mohona, P.S- Mejia, Dist- Bankura (Khalasi of the Dumper) and the owner of the said Dumper and arrange for its investigation and obliged.
