In producing herewith seized article i.e. (1) 03 (three) plastic made containers, 02 (two) loaded with approx 05 (five) litters each container & another loaded with approx 04 (four) litters liquid appearing to have been illicit liquor after collecting sample in a (2) one 600 ML plastic bottle loaded with approx 550 ml liquid from the seized container. (3) Some plastic glass & (4) one funnel from the premises of Sudhir Hansda as above. I, do hereby submit complaint against accused Sudhir Hansda S/O Bakul Hansda of Vill- Patamachla, P.O-Layekpara, P.S-Simlapal, Dist-Bankura to the effect that on 19/02/24 at about 16:25 hrs as per source information I along with force held raid at Patamachla village, P.O- Layekpara, P.S-Simlapal at the house premises of Sudhir Hansda S/O Bakul Hansda and found that above noted Sudhir Hansda was selling illicit liquor in a polithin glass from a plastic container. On seeing Police party he fled away and managed to conceal himself behind a bush. I along with force found I/D liquor and other related articles in the house at the premises of above noted Sudhir Hansda which was possessed and getting sold illegally. So, I seized the following articles in between 16:55 hrs to 17:25 hrs (1) 03 (three) plastic made containers, 02 (two) loaded with approx 05 (five) litters & another loaded with approx 04 (four) litters liquid appearing to have been illicit liquor after collecting sample in a (2) one 600 ML plastic bottle loaded with approx 550 ml liquid from the seized container. (3) Some plastic glass & (4) one funnel from the premises of Sudhir Hansda under proper seizure list as alamat.

So, I pray before you to start a case under proper section of law against accused Sudhir Hansda S/O Bakul Hansda of Vill- Patamachla, P.O-Layekpara, P.S-Simlapal, Dist-Bankura for illegal stocking and selling Id liquor also arrange for its investigation.




