In producing herewith seized article i.e. (1) 03 (three) plastic made containers, out of three 02 loaded with approx 10 (ten) litters each & another loaded with approx 04 (four) litters liquid appearing to have been illicit liquor (Total 24 Lts.), (2) one 600 ML plastic bottle loaded with approx 500 ml liquid as sample from the seized container. (3) 02 nos of Aluminum handi (Medium size). (4) Some plastic glass & (5) 02 funnel from the premises of Rabi Lochan Saren S/O Lt. Saban Saren of Badageria village, P.O- Mukundapur P.S-Simlapan, Dist-Bankura to the effect that on 23/02/24 at about 08:45 hrs as per source information I along with force held raid at Badageria village, P.O- Mukundapur, P.S-Simlapan at the house premises of Rabi Lochan Saren S/O Lt. Saban Saren and found that above noted Rabi Lochan Saren was selling illicit liquor in a polithin glass from a plastic container. On seeing Police party he fled away and managed to conceal himself behind a bush. I along with force found I/D liquor and other related articles in the house at the premises of above noted Rabi Lochan Saren which was possessed and getting sold illegally. So, I seized the following articles in between 09:15 hrs to 10:15 hrs (1) 03 (three) plastic made containers, out of three 02 loaded with approx 10 (ten) litters each & another loaded with approx 04 (four) litters liquid appearing to have been illicit liquor (Total 24 Lts.), (2) one 600 ML plastic bottle loaded with approx 500 ml liquid as sample from the seized container. (3) 02 nos of Aluminum handi (Medium size). (4) Some plastic glass & (5) 02 funnel from the premises of Rabi Lochan Saren under proper seizure list as alamat.

So, I pray before you to start a case under proper section of law against accused Rabi Lochan Saren S/O Lt. Saban Saren of Vill- Badageria, P.O- Mukundapur, P.S-Simlapan, Dist-Bankura for illegal stocking and selling ld liquor also arrange for its investigation. —
