Sub: First hand finding


Dear Sir,

It has been informed that on 30.03.2024, one along with other unauthorized person illegally trespassed in the prohibited area of Barjora (North) Coal Mine early morning hours, breaching the security surveillance, crossing the barbered fence and high drain with the ulterior motive of coal theft and was reported to be dead on the spot. Thereafter body was recovered from the spot with the help of local police and sent to Bankura Hospital.

WBPDCCL along with MDO (M/s Montecarlo Ltd.) regularly take efforts to resist the entry of illegal unauthorized persons, in the prohibited area of the mine. We have protected the entire area by way of fencing with barbered wire, displaying sign boards stipulated places showing prohibited and unsafe area, digging of deep drain, regular public announcement about the danger, ensuring regular police patrolling of the mine area and distribution of awareness leaflets to the public. Security personnel of M/s Montecarlo Ltd., MDO are posted round the clock for safety, security and surveillance of the mine. This type of trespassing of miscreants were earlier reported to your good office with various letters from our end.


You are requested to kindly register our finding in the form of complaint for theft of coal, trespassing in the protected area violating safety and security of the mine and taking necessary actions into the matter.
