Subject: - Prayer for lodging FIR against the arrested accused Tarun Gope Gorai (45 Yrs) S/O-Lt Narayan Ch. Gope Gorai of Vill- Lalbazar, PS-Barjora, Dist- Bankura (The owner cum driver of the tractor having Chassis No-1PY5105DJJA006884 & Engine No-PY3029D492797 fitted with trolley without any registration number plate) and others as per Law.

Sir,

In producing herewith one arrested accused person namely Tarun Gope Gorai (45 Yrs) S/O- Lt Narayan Ch Gope Gorai of Vill-Lalbazar, PS-Barjora, Bankura (The owner cum driver of the tractor having Chassis No-1PY5105DJJA006884 & Engine No-PY3029D492797 fitted with trolley without any registration number plate and along with seized alat viz. (i) One green colour John Deere company tractor having Chassis No. 1PY5105DJJA006884 & Engine No- PY3029D492797 fitted with trolley without any registration number plate & loaded with sand (Approx 80 cft). I, A.S.I. Tarun Kr Pain of Barjora P.S do hereby lodge a complaint, to the effect that today i.e. on 29.03.2024 at about 19:15 hrs while performing Jungle Mobile duty under Barjora Police Station area (vide Barjora PS CC No. 768/2024 dated 29.03.2024 and GDE No. 1644 dated 29.03.2024) received a secret information that one sand loaded tractor, coming towards Barjora side from Fulberia side, Accordingly, I informed the matter to I/C Barjora P.S while he pleased to direct me to work out the information immediately. Hence, I along with accompanying reached near Barjora BDO Office More under Barjora P.S and found that the above noted tractor was coming from Fulberia side on SH-09. Accordingly, we signalled to stop him but seeing the police in uniform the driver tried to flee away but somehow we managed to apprehend him. We summoned the local people to be witness during search but none responded my appeal. Finding no other alternatives I conducted search in presence of accompanying force. During checking of the above noted Tractor, we found that the Tractor is loaded with sand. Then I asked the driver of the intercepted Tractor to produce valid papers in respect of Tractor as well as loaded sand but he could not produce any valid documents in respect of sand and Tractor.

During interrogation he failed to give any satisfactory reply regarding his suspicious movement with sand loaded Tractor. I also asked him about the place from where they loaded the Tractor but he remain silent on repeated queries. So, it is highly suspected that the said sand loaded in the Tractor is stolen in nature and violated the provision of Mines and Minerals (Development and Regulation) Act. 1957.

Hence, I seized the above noted sand loaded Tractor in between 19:45 hrs and 20:05 hrs under proper seizure list duly signed by the witness and collected 2 K.G sand form the above noted Tractor in presence of the owner cum driver of the said tractor namely Tarun Gope Gorai near Barjora BDO Office More under Barjora P.S, Dist Bankura.

On interrogation he disclosed his identity as noted above which need to be verified and he also stated that they along with others collected this material by means of illegal way and going to the different places to sell the same to earn huge money and in this way they maintain their livelihood since long. He also stated that in this way they earned huge money and incurred government revenue since long. So, I arrested him at about 20:10 hrs from the spot i.e near Barjora BDO Office More under Barjora P.S after maintaining all the legal formalities and guidelines of Apex Court and NHRC.

Therefore, I pray to your good self that a specific case under proper section of law may kindly be registered against Tarun Gope Gorai (45 Yrs) S/O-Lt Narayan Ch. Gope Gorai of Vill-Lalbazar, PS-Barjora, Dist- Bankura (The owner cum driver of the tractor having Chassis No-1PY5105DJJA006884 & Engine No-PY3029D492797 fitted with trolley without any registration number plate) and others and arrange for its regular investigation.
