In producing herewith the 02 arrested accused persons namely (1) Srimanta Bauri (18) s/o Tarapada Bauri of vill-Dhaldanga, PS-Beliatore, Dist. Bankura. (2) Tushar Mahanto (26 yrs.) s/o Late Mahadeb Mahanto of vill- Petyakana, PS-Onda, Dist. Bankura along with the following seized articles (1) One red colour apache motor cycle bearing reg. no. WB-88F-3074. (2) One plastic jarricane containing approx 10 ltrs. of liquor having strong smell of ID Liquor out of which approx 375 ml. of Liquor is taken as sample in a glass bottle (3) One plastic jarricane containing approx 05 ltrs. of liquor having strong smell of ID Liquor out of which approx 375 ml. of Liquor is taken as sample in a glass bottle (4) One yellow and pink colour stripe nylon bag as per seizure list. I beg to submit that in course of my Mobile duty at Beliatore PS area vide Beliatore PS GDE No. 1206 dtd. 27.03.2024 and CC NO-877 Date- 27.03.2024. I received a secret information from my source that, one Srimanta Bauri of vill-Dhaldanga alongwith one other is illegally carrying Id liquor and moving towards Godardihi village under Beliatore PS in his motorcycle. Accordingly I shared the information to O/C Beliatore PS and as per his direction myself along with C/1714 Srimanta Singh, C/337 Sk. Md. Anarul and NVF/381 Braja Kishore Mahato rushed towards Godardihi village to work out the information.

After a while at about 16.35 hrs. on the way towards Godardihi village near Godardihi Pry. School. I found 02 persons going towards Godardihi village in a red motorcycle carrying a nylon bag. I stopped them and asked their name. The motorcycle rider identified himself as Tushar Mahanto (26 yrs.) s/o Late Mahadeb Mahanto of vill- Petyakana, PS-Onda, Dist. Bankura and the pillion rider identified himself as Srimanta Bauri (18) s/o Tarapada Bauri of vill-Dhaldanga, PS-Beliatore, Dist. Bankura on searching the bag I found 02 plastic jarricane containing approx 15 ltrs. of liquor having strong smell of ID Liqour. Approx 10 ltrs in one and approx 05 ltrs in other jarricane. There after I asked them to produce any valid document in respect of carrying such Id liquor but they failed to produce any valid document or to give any proper explanation.

Accordingly, I seized (1) One red colour apache motor cycle bearing reg. no. WB-88F-3074. (2) One plastic jarricane containing approx 10 ltrs. of liquor having strong smell of ID Liquor out of which approx 375 ml. of Liquor is taken as sample in a glass bottle (3) One plastic jarricane containing approx 05 ltrs. of liquor having strong smell of ID Liquor out of which approx 375 ml. of Liquor is taken as sample in a glass bottle (4) One yellow and pink colour stripe nylon bag under proper seizure list followed by proper sealing & labeling duly signed by the witnesses and accused persons. As the said accused persons namely (1) Srimanta Bauri (18) s/o Tarapada Bauri of vill-Dhaldanga, PS-Beliatore, Dist. Bankura. (2) Tushar Mahanto (26 yrs.) s/o Late Mahadeb Mahanto of vill- Petyakana, PS-Onda, Dist. Bankura committed an offence under Bengal Excise Act 1909. So, I arrested them under proper memo of arrest after maintaining all the guidelines as per Hon'ble Supreme court & N.H.R.C regarding arrest.

Therefore, I pray that a specific case may kindly be initiated against the accused persons namely (1) Srimanta Bauri (18) s/o Tarapada Bauri of vill-Dhaldanga, PS-Beliatore, Dist. Bankura. (2) Tushar Mahanto (26 yrs.) s/o Late Mahadeb Mahanto of vill- Petyakana, PS-Onda, Dist. Bankura under proper section of law.
