Sir,

You are hereby informed that during routine patrolling at forest area of Brindabanpur Beat jurisdiction under Beliatore Range on dated 28/03/2024 at about 10:30 am, some villagers bearing head load with forest produce by cutting down with illegal entry into the forest land and the staffs, Shree Shambhunath Banerjee, FG and Shree Rakesh Konai, FG obstructed them on their way to home, at that time the accused named Lalu Bauri, son of Late Jabbar Bauri of Brindabanpur Village came in front of them with loud voice by giving threat to life and launched physically assault with axe upon those staffs and during huddle one of staff named Rakesh Konai, FG fell down on the ground and got injured and he was brought to the hospital with several cut mark on his left hand at Beliatore for medical treatment (Doctor's Prescription attached). Hence he has committed an offence to interrupt the Govt. duty and threaten to life and property. Thus makes us insecure to our Govt. duty.

Under such circumstances please do needful as per rule and regulation under CrPC.
