Subject- Prayer for lodging FIR against the accused person namely Sunil Ghorui (55 yrs) @ Mathur S/o- Lt Sankar Ghorui of Village- Bhairabdanga, PS- Beliatore, Dist- Bankura.

Sir,

In producing here with the arrested accused person namely Sunil Ghorui (55 yrs) @ Mathur S/o- Lt Sankar Ghorui of Village- Bhairabdanga, PS- Beliatore, Dist- Bankura along with seized article 1) One 20 ltrs. plastic jarricane containing approx 20 ltrs liquor having strong smells of I.D liquors out of which approx 375 ml liquor having strong smells of I.D liquors taken as sample in a glass bottle with original seizure list and other related documents.

The fact is that today on 11.03.2024 at 18:05 hrs. Myself ASI Rabilochan Shit of Beliatore P.S along with my accompanying force left PS to perform night mobile duty at Khag jungle area vide GDE no- 484 date- 11.03.2024 and CC no- 623/24, While performing duty at about 18.25 hrs. I received an information from my reliable source that one Sunil Ghorui (55 yrs) @ Mathur S/o- Lt Sankar Ghorui of Village- Bhairabdanga, PS- Beliatore, Dist- Bankura is use to store ID liquor illegally in his house at vill-Bhairabdanga under Beliatore P.S in a view to sell it in locality illegally. Accordingly, I informed the matter to my O/C and as per his direction, I along with C/977 Sujit Dutta, C/1813 Utpal Neogi and NVF/288 Asish Mahato left for Bhairabdanga village under Brindabonpur GP to work out the information. At about 18:45 hrs myself alongwith my accompanying force arrived in the house of Sunil Ghorui at Bhairabdanga village. I found one person in the house I asked his name and address. On asking he disclosed his name and address as Sunil Ghorui @ Mathur s/o Late Sankar Ghorui. I interrogated him and asked regarding selling/storing of ID liquor in his house. Apparently he denied of having any I.D Liquor in his house. Hence I held raid in his house and found one plastic jarricane of at about 20 ltrs kept in a corner of his house. I searched the said plastic jarricane and found it is filled with approx 20 ltrs. of liquor having strong smells of I.D liquors. I detained him and once again interrogated him, during interrogation he confessed that he has stored this ID liquors with a view to sell in the locality. I asked him to produce any valid documents in respect of selling ID liquor, but he failed to produce any such documents in respect of this. Accordingly, I seized 1) One 20 ltrs. plastic jarricane containing approx 20 ltrs liquor having strong smells of I.D liquors out of which I took out approx 375 ml liquor having strong smells of I.D liquors as sample in a glass bottle under proper seizure list duly sealed and labelled by me in presence of the witnesses and arrested the accused person Sunil Ghorui (55 yrs) @ Mathur S/o- Lt Sankar Ghorui of Village- Bhairabdanga, PS- Beliatore, Dist- Bankura after maintaining all the direction of Hon'ble Supreme Court and NHRC.

I also conducted a local enquiry and it came to learn that the accused person Sunil Ghorui@Mathur often use to sell I.D liquor in the locality illegally since long.

Under the above circumstance, I request you to start a specific case under proper section of laws against the accused person namely Sunil Ghorui (55 yrs) @ Mathur S/o- Lt Sankar Ghorui of Village- Bhairabdanga, PS- Beliatore, Dist- Bankura and arrange for its investigation.
