Sub:- Prayer for lodging specific case.

Sir,

In producing here with the two seized vehicles viz one loaded Truck bearing Regi no-WB53C/3467 and one Motor-cycle bearing Regi no-WB34BS/7450; I ASI Durjodhan Maji of Bishnupur P.S. beg to state that today (29.02.24) myself along with force was performing anti-crime mobile patrolling duty in PS area vide Bishnupur PS GDE No- 1737, Dt-29.02.24, and C.C. no- 644/24, Dt-29.02.24. During my patrolling duty, at about 18.25 hrs, I received an information that an accident occurred near Morar 1 no camp bazaar. After receiving the information, I intimated the same to I/C Bishnupur P.S., and rushed to the spot. On arrival at spot, (on NH-60 Road, proceeding towards Bankura- West Midnapore), I saw that a gathering is there. Two persons laying on the ground, with severe bleeding injury. One of them is seen as spot dead. Immediately, I with my accompanied force, local persons managed to shift the persons to Bishnupur District Hospital. The loaded Truck was on the road, driver is not found at the moment, and the Motor-cycle is also there in damaged condition.

Local enquiry reveals that, the Truck (WB53C/3467) was coming from Midnapore side in high speed, and the Motor-cycle (WB34BS/7450) was coming from opposite direction in normal way. The two injured were the rider and pillion rider of the motor-cycle. It is also known that the incident occurred due to rash and negligent driving of the driver of the said Truck. The injured persons were not local persons, so none of the persons could identified them, at the moment. Thereafter, I seized both the vehicles in between 20.05hrs to 21.15hrs, as per proper seizure list, and cleared the traffic flow of the road.

After a few hours, primary identity of the two persons received as known as Pritam Sar of vill-Bhaudi, PS- Salboni, Dist- Paschim Medinipur, (dead) and another severe injured Sandip Sen of vill-Babuibasa, PS- Salboni, Dist- Paschim Medinipur. Further detail is not known so far.

So, I pray before you to register a specific case in this regard, as per proper section of law, for proper investigation of the incident.
