Sub:- Prayer for lodging FIR against Madan Mal (Approx 30 yrs) S/O- Ranjan Mal of Gabdoba Bypass, PS-Bishnupur, Dist- Bankura.

Sir,

In producing here with one arrested accused person namely Madan Mal (Approx 30 yrs) S/O- Ranjan Mal of Gabdoba Bypass, PS- Bishnupur, Dist- Bankura along with one seized single shot pipe gun having diagonal length (from barrel to butt) approx. 24 cm & the butt is made of wood & covered by red color tape loaded with one (01) round live ammunition having length of 7 cm (approx.) & another one round of live ammunition having length of 7 cm (approx.), under proper seizure list & label; I beg to state that today on 29.02.24 at about 22:15 hrs while performing special anti-crime town night mobile, received a credible source information that one person is moving suspiciously in between Birai More & Bhagat Singh More.

Accordingly, as per your kind order I, SI Arindam Senapati along with SI Koushik Choubey & force moved towards the spot & on arrival near Hatipool railway overbridge in between Birai More & Bhagat Singh More at about 22.35 hrs we found one person is moving aimlessly at that spot. We managed to apprehend the said person & interrogated him. During interrogation, he disclosed his identity as Madan Mal (Approx 30 yrs) S/O-Ranjan Mal of Gabdoba Bypass, PS- Bishnupur, Dist- Bankura but he answered haphazardly about his late night movement & hence I searched him thoroughly in presence of one independent witness & my accompanying force and found one single shot pipe gun having diagonal length (from barrel to butt) approx. 24 cm & the butt is made of wood & covered by red colour tape loaded with one (01) round live ammunition having length of 7 cm (approx.) from his hiding behind the waist & another one round of live ammunition having length of 7 cm (approx.) from the left side of pocket of his pant. I asked him to produce valid license of it but he failed to do so and was not even able to give any satisfactory answer to that. After prolong interrogation he admitted that he is moving at this area with an intention to commit crime by using the aforesaid arms.

Accordingly, I have arrested said Madan Mal after observing all the legal formalities of NHRC guideline & I have seized the said improvised single shot pipe gun having diagonal length (from barrel to butt) approx. 24 cm & the butt is made of wood & covered by red color tape loaded with one (01) round live ammunition having length of 7 cm (approx.) & another one round of live ammunition having length of 7 cm (approx.), Here I like to note that at that time one person namely Uday Majhi is moving towards Bhagat Singh More & seeing us he stopped there. On being asked he agreed to see the search & seizure procedure & hence I have taken his signature as witness in the seizure list. There was no one present except the said Uday Majhi at this odd hours of night & hence I have taken his signature as well as my accompanying police personnel's signature in witness column of the seizure list.

Therefore, I pray before you that one specific case may kindly be started under proper section of Arms Act.
