Respected Sir,

In producing here with seized article 19 liters colorless liquor in a plastic jariken from which strong smell of I.D liquor is coming out (approx. value of Rs. 825/-) and one bottle containing approx. 350 ml of colorless liquor having strong smell of I.D liquor collected as sample from the above noted plastic jerkin duly sealed and labeled by me. I, S.I. Koushik Choubey of Bishnupur P.S do here by lodge complaint against one Sunil Saren, S/O- Chunaram Saren of Bhimerdanga, Morar, PS-Bishnupur, Dist-Bankura to the effect that today on 01.03.24 at about 17:05 hrs I have received a secret information regarding illegal sell of Id. liquor is going on from his house at Bhimerdanga village. Accordingly, I informed I/C Bishnupur PS and as per his direction and being accompanied by my team of Bishnupur PS including lady police personnel in Police uniform left PS to work out the information.

On 01.03.2024 at about 17.55 hrs, I along with force reached at the said house. I left my vehicle at a certain distance. We entered the house and found that seeing Police, some persons who were taking and selling liquor in the house started to flee away. We chased them but all of them including the seller namely Sunil Soren somehow managed to escape.

I along with force searched the house in between 18:15 hrs and 18:45 hrs, seized 19 liters colorless liquor in a plastic jariken from which strong smell of I.D liquor is coming out (approx. value of Rs. 825/-) and one bottle containing approx. 350 rd of colorless liquor having strong smell of I.D liquor collected as sample from the above noted plastic jerkin from inside the house of Sunil Saren, S/O- Chunaram Saren of Bhimerdanga, Morar, PS-Bishnupur, Dist-Bankura after preparing proper seizure list duly signed by the witnesses. On demand, no one came forward in favor of seized items and failed to produce any license or any valid document in favor of selling I.D liquor. On local enquiry, I came to learn that the name of the owner of the house is Sunil Saren, S/O- Chunaram Saren of Bhimerdanga, Morar, PS-Bishnupur, Dist-Bankura & he is running this illegal business since long. However, in course of investigation of the case the name of the owner of the house is need to be verified. Being asked the local witnesses who were present there refused to sign in seizure list and labels. Finding no other alternative, I took signature of my accompanying force as seizure witness.

Under the above fact and circumstance, I request you to start a specific case against the said accused namely Sunil Saren, S/O- Chunaram Saren of Bhimerdanga, Morar, PS-Bishnupur, Dist-Bankura under proper section of law and arrange for its investigation.

- 1. One plastic jariken containing about 19 liters of colorless liquor having strong smell of I.D liquor,
- 2. One bottle containing approx. 350 ml of colorless liquor having strong smell of I.D liquor collected as sample from SI no- (1),

Under the above fact and circumstances, I pray before your kind self that a specific case may kindly be registered against the above noted accused person under proper section of law and arrange for its investigation.
