Sub: Prayer for lodging FIR.

Sir,

In producing here with two (02) arrested accused persons namely (i) Bappa Mondal (36 yrs) S/O Shymapada Mondal of Kadakuli, Bishnupur Municipality ward No 06 PS Bishnupur Dist Bankura and (ii) Nikhil Lohar (46 yrs) S/O Lt Nagendranath Lohar of vill Gossainpur PO Chakdaha PS Bishnupur Dist Bankura along with seized two (02) improvised Engine vans, loaded with sand amounting twenty(20) plastic sacks each van about 75 cft in total after preparing proper seizure list. On 12.03.24 at 05. 55 hrs while performing jungle night mobile duty vide Bishnupur PS GDE No 647 dt. 11.03.24 & CC No. 822/24 dated 11.03.2024 I PSI Akash Patra and along with force received an source information that two improvised Engine vans carrying sand illegally without any valid challan is coming from Harighat to Bishnupur town via Sakharibazar road. Accordingly, myself along with my accompanying force placed naka duty near Sakharibazar Poddar Para.

During that period at about 6.05 hrs. we found that two (02) improvised Engine vans loaded with sand are coming from Harighat side towards Bishnupur town. On suspicion we proceeded towards two (02) improvised Engine vans and found that Vans are loaded with sand. Thereafter, I asked the drivers of said vans to produce valid documents in respect of the said vehicles and loaded sand. But they neither produce any such valid documents in support of their vehicles and loaded sand respectively nor give any satisfactory account in this regard which made to believe that the said persons are stealing the sand habitually by fraudulent means and transported the sand to elsewhere to sell the same. On examination the above noted persons made different statements in different times. Later on they admitted that they habitually deal with sand illegally. They used to load sand from different sand mines of Dwarokeshar river without any valid documents and transported the same by fraudulent means for selling the same. Thus, they are habitually stealing the sand and transporting and selling the same illegally by fraudulent means without paying any revenue to the Govt.

Then I arrested them and informed them regarding their ground of arrest and issued memo of arrest after maintaining all legal formalities. So far

transport the stolen sand and conceal those in different places for selling and they are habitual dealer of stolen sand. Thereafter, I seized two (02) improvised seized Engine vans, loaded with sand amounting twenty (20) plastic sacks each about 75 cft in total under proper seizure list from the above noted persons duly signed by them and witnesses in between 06.25 hrs to 06.30 hrs.

Under the above circumstances I therefore pray that a Specific Case may kindly be started under proper Section of Law against arrested accd persons namely (i) Bappa Mondal (36 yrs) S/O Shymapada Mondal of Kadakuli Bishnupur Municipality ward No 06 PS Bishnupur Dist Bankura and (ii) Nikhil Lohar (46 yrs) S/O Lt Nagendranath Lohar of vill Gossainpur PO Chakdaha PS Bishnupur Dist Bankura and arrange for its investigation and oblige.
