

Complaint under section 156 (3) Cr PC against accused persons for the commission of highway dacoity, dacoity with fire arms, assault, and others under section 400,394, 352, 384, 120B, 420, 34 IPC and under section 25 and 27 Arms Act.

The complainant most respectfully begs to state following:

That accused 1. Branch Manager namely Argha Sanyal of HDB FINANCIAL SERVICES LTD of Durgapur City Center, Durgapur branch, 2. Branch Manager of HDB FINANCIAL SERVICES LTD, Bishnupur, Jhapormore, near AXIS Bank, Post & Ps: Bishnupur, District: Bankura, Pin: 722122, and 3. Branch Manager of HDB FINANCIAL SERVICES LTD, First Floor, Lalbazar, Durgapur, Bypass Road, Ward No: 6, Post, Ps & District: Bankura, Pin: 722101were started blackmailing the complainant if he doesn't repay entire loan amount to them immediately at the rate of 11.14%, they would send a group of goons or dacoits who all are company men to snatch vehicle forcibly from road or from house of complainant. Vehicle registration no is WB 87 0442, Chassis no: MB1AA22E0NRMT6798, Engine no: NMH061027P, vehicle class: GOODS CARRIER, makers name: ASHOK LEYLAND LTD., Model Name: AL DOST STRONG LE, color is IRISH CREAM, fuel used DIESEL, BHARAT STAGE VI, CC: 1478.00. same has been hypothecated with the for Rs 7, 60,500 (rupees seven lack sixty thousand and five hundred only) HDB FINANCIAL SERVICES LTD whereas the complainant has already paid Rs 3, 17,700 till now. Thereafter said accused managers of HDB FINANCIAL SERVICES LTD were again started extortioning the complainant for money Rs 50,000 cash to them for causing delay of repayment of loan which offer the complainant had turned down. It is pertinent to mention here that at the time of execution of loan agreement and contract with HDB FINANCIAL SERVICES LTD they settled EMI Rs 16,800 at the rate of 8.5% interest which they immorally hiked at the rate of 11.14% after sanctioning of loan to the complainant in the midterm.

On 10/1/2024 at about 11.45 pm when the complainant along with his khalasi or helper were left for loading paddy with said vehicle from Sourav Dey of Barpeta, Ramsagar under Onda Police Station by road, a group of more than five unknown persons who all were armed with weapons, fire arm, led by managers of HDB FINANCIAL SERVICES LTD above named stopped the vehicle on Bankura to Medinipur National High Way, near Morar Jungle, under Bishnupur Police Station committed dacoity of said vehicle during pendency of a civil suit against them who



are managers of HDB FINANCIAL SERVICES LTD before Ld Civil Judge (Junior Division) At Bishnupur being TS Case No: 121/2023 by assaulting the complainant and khalasi due to that the complainant was apprehending about their illegal act of commission of dacoity of said vehicle from lawful possession of the complainant. Be it noted said managers are contesting TS Case 121/2024 which is subjudice. Furthermore those accused persons came with a vehicle bearing registration no: WB 60L 7171 SAFARI STORM. Later on the complainant has come to know those accused persons have carried said vehicle to Biswakarma Parking Zone, Itahar, District: Uttar Dinajpur. Where the complainant immediately contacted and searched for said vehicle, found they have kept said vehicle there with an ulterior motive to cause wrongful loss to the complainant and also cause sale the same for more price in secrecy. They again had forcibly collected signature of the complainant upon few forms, documents on the very same day of dacoity by putting the complainant in fear of death.

Aggrieved by their illegal act of snatching my said vehicle with the help of dacoits, the complainant being compelled to lodge complaint with the Inspector-in-charge, Bishnupur Police Station for taking legal action against those Branch Managers Namely 1. Argha Sanyal, Branch Manager of HDB FINANCIAL SERVICES LTD of Durgapur City center, Durgapur branch, 2. Branch Manager of HDB FINANCIAL SERVICES LTD, Bishnupur, Jhapormore, near AXIS Bank, Post & Ps: Bishnupur, District: Bankura, Pin: 722122, 3. Branch Manager of HDB FINANCIAL SERVICES LTD, First Floor, Lalbazar, Durgapur, Bypass Road, Ward No: 6, Post, Ps & District: Bankura, Pin: 722101 and their group of dacoits whom the complainant and his khalasi can identify, bring all the accused persons under justice and also recover said vehicle from them and return the same vehicle from dacoits. But Inspector-in-charge, Bishnupur Police Station made no effort for recovering the same despite lodging complaint. Copy of complaint has been duly served upon both the I.C. Bishnupur Police Station and S.P. Bankura which is appended here with.

Prayer

Hence it is most graciously being prayed that your Honor may be pleased to pass an order under section 156 (3) Cr PC for registering FIR against those accused persons for the commission of armed dacoity, forcibly taking away or snatching the vehicle from the lawful custody of the complainant during pendency of TS Case in connection



of said vehicle before Ld Civil Judge (Junior Division) At Bishnupur ignoring Ld Court and also prayed to restore the same in original possession of complainant, bring all the accused persons under justice, considering above stated facts and circumstances
