Vehicle No. – JH 19B3599 loaded the TMT Bar 12.360 MT of Rs. 6,64,637/- & 12.330 MT of Rs. 6,65,690/- to deliver the same to Buyer & Consignee Home Solution vide invoice no. – SRRPL/5766/23-24 dated 02/03/2024 & SRRPL/5767/23-24 dated 02/03/2024 respectively. (Copy of Tax Invoice, E-way bill, Transporter's Bilty, Vehicle Registration Certificate & Driving Licence is enclosed for your ready reference).

The both trucks were likely to reach the consignee's place by the morning on 05/03/2024. But, the trucks have not reached till today. We have also not getting any response from transporter or from drivers of both vehicles.

We are afraid that goods i.e. TMT Bar have been misappropriated by the transporter or drivers.

Therefore, we request to register an FIR in the matter and recover the goods and do the needful in the matter.
