The complainant most respectfully begs to state following:

Received on 11/03/24 at 14.05 hrs and started Indas ps case NO -47/24, A- 11/03/24 U/s 448/323/354/506/34 IPC.



That on 16/01/2024 at about 11 am to 11.30 am brothers of complainant namely 1. Mahadeb Dutta S/O Late Abhay Pada Dutta resident at Village & Post: Mongalpur, Ps: Indas, District: Bankura and 2. Jagannath Dutta S/O Late Abhay Pada Dutta resident at Village & Post: Mongalpur, Ps: Indas, District: Bankura and 3 Younger sister-in-law Monimala Dutta W/O Jagannath Dutta resident at Village & Post: Mongalpur, Ps: Indas, District: Bankura suddenly barged into residential house of complainant and started attacking indiscriminately the complainant, his wife and son of complainant with a huge log of tree. Due to that complainant along with his son and his wife sustained mild to major injuries. That above named two brothers had flogged wife of complainant with a stick on her legs, thighs and buttock after disrobing her sari from behind her back, tore her sari, blouse with intent to outrage her women modesty. That the complainant and his family members were brutally attacked by those above named assailants due to the protest launched for openly discharging dirty water on the 12' ejaml road from their illegal and unauthorized constructed lavatory and bathroom. Immediately after said brutality the complainant went to lodge complaint with the Officer-in-charge of Indas Police Station which he had turned down to accept for political intervention.
