Sub - Identification of highspeed, reckless and carelessly driving car which hit the bike and to take necessary action against it.

Sir,

I, Shri Arjit Halder, S/o- Tarachand Halder, R/o- Khatra Netaji Road, P.O+P.S.- Khatra, Dist- Bankura, I would like to inform you that on 24/02/2024 my father Shri Tarachand Halder, S/o- Late Gopal Ch. Halder and my mother Smt. Sima Halder, both are resident of Khatra Netaji Road, P.O+P.S.- Khatra, Dist- Bankura, were returning home on bike, having registration no. WB 68F8990, after completion of Puja at Aralbansi Yogomaya Mandir. On that day (24/02/2024) at 12.50pm - 12.55pm just before the Nuniabad village (After the end of Bagdaha's down road and start of the plain road) an unknown high speed four wheeler which was recklessly and carelessly driving hit the bike to do overtake. As a result both the passengers (My father and mother) fell on the road. Immediately with the help of local villagers and Police they were taken to the Bankura Sammilani Medical College. On that day (24/02/2024) after the referral of Sammilani Medical College doctors, with the help of the family members both my parents were admitted at The Mission Hospital, Durgapur. My mother was severely injured and she is in ICU, till now fighting with death. Her condition is grave. My father was also injured and several operations were done to both of them. We, the family members were busy in taken care of my parents for their treatment.

My humble request to you is to treat this application as FIR complaint for immediate identification of the four wheeler and take required action against the reckless and high speed four wheeler as early as possible.
