Sir,

I S.I Subir Pati of Kotulpur PS. Dist.Bankura to hereby lodge the complaint against P.C. accused person namely Bapan Karmakar [M/27yrs] S/O-Swapan Karmakar of Vill- Ganti panchpara , , P.S-Kotulpur, Dist-Bankura along with seized fire arms i.e one improvised revolver where it is written on barrel and body USA32 having butt,body barrel trigger,trigger guard and firing pin with 02 (two) Pcs live ammuniion., The measuring barrel approx. 7 innch " and butt approx. 6.5 inch " and body 3 inch . I beg to state that today i.e on 17.03.2024 at 18.15. hrs I introgate the above noted P.C. accd. person in C/W Kotulpur P.S. case no 70/24 dt. 13.03.2024 .and he stated that he has a fire arms in a secret place and he use the same during commit crime .Accordingly I inform the matter to O/C Kotulpur P.S. and diarized the matter,vide kotulpur P.S. G.D. No-913 dt. 17.03.2024

Accordingly, as per order of O/C Kotulpur P.S, I along with others officers and force took preparation to wok out the information and left for Ganti evening mobile officer ASI Goutam Mondal and forces also join with me for assistance to held raid in house P.C. accd. Bapan Karmakar [M/27yrs] S/O-Swapan Karmakar of Vill- Ganti panchpara , , P.S-Kotulpur, Dist-Bankura

As such, I, SI Subir Pati along with force C/317 Pradip Mondal , C1436 Somenath Rajak , NVF Manas Mahanty accompanied with ASI Gotam Mondal ,C/1457 ~~Sudam~~ ^{Sudam} Pramnik NVFSoumen Mahato Vide Kotulpur P.S. C.C. No 685/24 Dt. 17.03.2024 held search in the house of Bapan Karmakar [M/27yrs] S/O-Swapan Karmakar of Vill- Ganti panchpara , P.S-Kotulpur, Dist-Bankura. During raid he was present in his house, I detained him and interrogated him regarding modus operandi of the crime which he already committed in C/W Kotulpur P.S. Case No 70/24 dt. 13.03.2024 U/S-379 I.P.C. and others crime. During interrogation he confessed his guilt and brought out improvised revolver where it is written on barrel and body USA32 having butt,body barrel trigger,trigger guard and firing pin with 02 (two) Pcs live ammuniion. I asked him to produce license of it but he failed and not able to give any satisfactory answer. I seized the said gun under preparing proper seizure list duly signed by the witnesses. After that I along with force return P.S. with P.C. accd. and seized fire arms.

Therefore, I pray before you that one specific case may kindly be started against Bapan Karmakar [M/27yrs] S/O-Swapan Karmakar of Vill- Ganti panchpara , , P.S-Kotulpur, Dist-Bankura under proper section of Arms Act
