In producing herewith one country made improvised Pipe gun measuring about 9 inch in length with butt, body, barrel, firing pin and trigger etc with one .303 live ammunition original seizure list.

I do here by lodged a written complaint to the effect that on 13.03.2024 at about 20:45 hrs during my Naka Checking duty at Naricha under Patrasayer P.S vide Patrasayer P.S G.D.E No.-568, dated-13.03.2024, C.C No.-692/24, dated-13.03.2024, On receipt an information from reliable source that two person are coming from Bishnupur side towards Patrasayer carrying with unauthorized arms for sale fire arms in lieu of money. After few while, I noticed that two person are coming from Bishnupur side with his Motor Cycle, as same description describe by the reliable source. I also again noticed that two unknown persons are coming near the Naricha Naka check post with Suspicious mood. Accordingly I tried to detain them but on seeing the police party they managed to escape from this spot towards Birsing jungle. Then I noticed that something like a butt of small fire arms was seen from those unknown person.

After that myself along with force chased them with a view to apprehend those person but in vain. On close observation it is revealed that one country made improvised Pipe gun measuring about 9 inch in length with butt, body, barrel, firing pin and trigger etc with one .303 live ammunition is lying on the jungle side road which was kept in the waist being kept supported with the pant of those unknown person.

Accordingly I seized the fire arms and ammunition under proper seizure list as unclaimed which is duly signed by the police party as no public witnesses could be found available at this deadly hours of night Naka checking and I also sealed and labeled separately in between 22:05 hrs to 22:45 hrs properly.

Hence I pray that a specific case U/S- 25/27 Arms act may kindly be stated and arranged for investigation and obliged.
