Respected Sir,

In producing herewith one arrested accused person namely Saker Ali Bhangi (M/52Y), S/O- Sajad Bhangi of Vill - Metyadahar, PO - Guiadaha, P.S -Garhbeta, Dist - Paschim Medinipur and one seized white colour six wheeler Dumper having Reg. No. WB15D 0499 loaded with approx 260.0 cft illegal sand under proper seizure list. The fact of the case in brief is that, on 29.02.2024 at about 17.15 hrs I along with force was performing mobile duty at Asthasole more under Amdangra OP area vide Amdangra Out Post C.C No- 159/24, dated- 29.02.2024 and GDE No-1035, dated - 29.02.2024. That time I found one suspected dumper having Reg. No. WB15D 0499 coming from the Mamra village side. I along with force stopped the dumper and found it loaded with sand. I asked the driver of the dumper to produce any valid documents regarding possession and transportation of the loaded sand. He failed to produce any valid documents in this respect. During interrogation he disclosed his identity as Saker Ali Bhangi (M/52Y), S/O- Sajed Bhangi of Vill -Metyadahar, PO - Guiadaha, P.S - Garhbeta, and Dist - Paschim Medinipur . During further interrogation the driver stated that he is the owner of the said vehicle and he loaded the sand in his dumper by fraudulent means after stealing the same from Shilabati riverbed under Paschim Medinipur district and transporting the same to Sabrakone area under Taldangra PS, Dist - Bankura for its concealment to hoard it at any secret places for selling the same to different persons for his illegal gain. He also admitted that he has been dealing with stealing sand from different areas and selling it to different places for his personal gains and thus causing huge loss to the Govt. revenue. Accordingly I seized the sand loaded dumper having Reg. No. WB15D 0499 under proper seizure list duly signed by my accompany police forces and also searched for independent public witness but found no one to sign as a witness. After that I arrested him after maintaining all legal formalities regarding arrest and also observed the guidelines of N.H.R.C and apex court. The sand loaded dumper has been kept at OP compound for safe custody.

So, I request you to lodge a specific case against the arrested accused driver namely Saker Ali Bhangi (M/52Y), S/O- Sajad Bhangi of Vill - Metyadahar, PO - Guiadaha, P.S - Garhbeta, Dist - Paschim Medinipur as per specific section of law and arrange for investigation.
