Respected Sir,

In producing herewith the arrested accused person namely Suman Acharya (28 Yrs) S/O- Chandi Acharya of Sakhari Bazar, PS- Bishnupur, Dist- Bankura along with the seized article as noted below. I, ASI. Achyut Mandal of Bishnupur P.S do here by lodge complaint against one Suman Acharya (28 Yrs) S/O- Chandi Acharya of Sakhari Bazar, PS- Bishnupur, Dist- Bankura to the effect that today on 28.03.24 at about 18:35 hrs during my Highway mobile duty (vide Bishnupur PS GDE No. 1510 dated 28.03.2024) I have received a secret information regarding illegal selling of Id. liquor is going on in a road side rice hotel namely Priya Hindu Hotel situated at beside the NH60 road near Bishnupur railway station. Accordingly, I informed I/C Bishnupur PS and as per his direction and being accompanied forces in Police uniform going to work out the information. At about 19:05 hrs, I along with force reached at the said place. I left my vehicle at a certain distance and we found that seeing Police, some persons who were taking and selling liquor in the road side rice hotel namely Priya Hindu Hotel of Suman Acharya started to flee away. We chased them and apprehended seller namely Suman Acharya. He was selling liquor at the Priya Hindu Hotel. We gave our identity as police personnel of Bishnupur Police Station and then told him the information which we had with us and to work out the information his hotel requires to be searched. Before searching the hotel, we told him that if he wants he may search us, which he denied. Then myself along with force started to search his hotel in his presence.

During search we found some id liquor. I interrogated Suman Acharya and during interrogation they confessed that he was running this business since last 6 months without any valid license. So, I arrested him for proper investigation of this case and seized id liquor in between 19:45 to 20:15 hrs. After seizure I labeled the same properly.

The description of the seized articles is given below:

1. One plastic jariken containing about 19 liters of colorless liquor having strong smell of I.D liquor,
2. One bottle containing approx. 350 ml of colorless liquor having strong smell of I.D liquor collected as sample from SI no- (1)

Under the above fact and circumstance, I request you to start a specific case against the said accused namely Suman Acharya (28 Yrs) S/O- Chandi Acharya of Sakhari Bazar, PS- Bishnupur, Dist- Bankura under proper section of law and arrange for its investigation.
