In producing here with the arrested accused person namely Kartick Bauri (32y) @ Kochi S/o- Lt Deul Bauri of Village- Purusuttampur, PS- Beliatore, Dist- Bankura along with seized articles 1) One 5 ltrs. white jarricane containing approx. 05 ltrs liquid smells like I.D liquors out of which approx 375 ml liquid smells like I.D liquors taken as sample in a glass bottle 2) One 5 ltrs. white jarricane containing approx. 05 ltrs liquid smells like I.D liquors out of which approx 375 ml liquid smells like I.D liquors taken as sample in a glass bottle 3) One 2 ltrs. plastic bottle containing approx. 02 ltrs liquid smells like I.D liquors taken as sample in a glass bottle 3) One 2 ltrs. plastic bottle containing approx. 02 ltrs liquid smells like I.D liquors taken as sample in a glass bottle 4) 02 nos. of nylon bags in which the above noted articles carried by the accused person, with original seizure list and other related documents.

The fact of the case in brief is that today on 10.03.2024 at 18:15 hrs. Myself SI Sanjoy Kr Mondal of Beliatore P.S along with my accompanying force left PS to perform my night mobile duty at Khag jungle area vide GDE no- 421 date-10.03.2024 and CC no- 609/24, While performing duty at about 18:25 hrs. I received an information from my reliable source that one Kartick Bauri (32y) @ Kochi S/o- Lt Deul Bauri of Village- Purusuttampur, PS- Beliatore, Dist- Bankura is selling ID liquor illegally at Saulia village near Saulia Primary School. Accordingly, I informed the matter to my O/C and as per his direction, I along with C/1836 Bibekananda Ghosh, C/736 Biswanath Bauri and HG/27 Mahadev Pandey left for Saulia village under Brindabonpur GP to work out the information. At about 18:40 hrs myself along with my accompanying force arrived at Saulia village near Primary School, where I found one person standing carrying 02 nylon bags in his hand. I detained him and asked his name and address. On asking he disclosed his name and address as noted above. I searched both the nylon bags on his possession and found one 05 ltrs, white jarricane containing approx. 05 Itrs liquid smells like I.D liquors in one bag and one 05 Itrs. white jarricane containing approx. 05 Itrs liquid smells like I.D liquors and a 02 Itrs. plastic bottle containing approx. 02 Itrs liquid smells like I.D liquors in another bag. I interrogated him, during interrogation he confessed that he is carrying this ID liquors with a view to sell in the locality. I asked him to produce any valid documents in respect of selling of this ID liquor, but he failed to produce any such documents in respect of this. Accordingly, I seized 1) One 5 ltrs. white jarricane containing approx. 05 ltrs liquid smells like I.D liquors out of which approx 375 ml liquid smells like I.D liquors taken as sample in a glass bottle 2) One 5 ltrs. white jarricane containing approx. 05 Itrs liquid smells like I.D liquors out of which approx 375 ml liquid smells like I.D liquors taken as sample in a glass bottle 3) One 2 Itrs. plastic bottle containing approx. 02 Itrs liquid smells like I.D liquors out of which approx 375 ml liquid smells like I.D liquors taken as sample in a glass bottle under proper seizure list in presence of the witnesses and arrested the accused person Kartick Bauri (32y) @ Kochi S/o- Lt Deul Bauri of Village- Purusuttampur, PS- Beliatore, Dist- Bankura after maintaining all direction of Hon'ble Supreme Court and NHRC.

I also conducted a local enquiry and it came to learn that the accused person Kartick Bauri often use to sell I.D liquor in the locality illegally since few days.

Under the above circumstance, I request you to start a specific case under proper section of law against the accused person namely Kartick Bauri (32y) @ Kochi S/o- Lt Deul Bauri of Village- Purusuttampur, PS- Beliatore, Dist- Bankura and arrange for its investigation.
