Respected Sir,

In producing here with the two arrested accd namely (1) Mokibul Islam ( 33 yrs ) S/O Mobarak Ali of vill Maheshpur Post Maheshpur Murakata , PS Chandrakona Town Dist Paschim Medinipur (Driver of Tata Motors Goods carrier truck bearing no WB33A6427 , Chassis No 426031HRZ014941 and Engine No 80H62701467) ( 2 ) Barkatulla Bhangi ( 23 yrs ) S/O Najimuddin Bhangi of vill Maheshpur Post Maheshpur Murakata , PS Chandrakona Town Dist Paschim Medinipur (Helper of Tata Motors Goods carrier truck bearing no WB33A6427 , Chassis No 426031HRZ014941 and Engine No 80H62701467 along with one Tata Motors Goods carrier truck bearing no WB33A6427 , Chassis No 426031HRZ014941 and Engine No 80H62701467 loaded with sand after preparing proper seizure list.

I PSI Akash Patra of Bishnupur PS lodged complaint as suo-moto that today on 02.04.24 at about 08:45 hrs while performing day mobile duty (vide Bishnupur PS GDE No 85 dt 02.04.24 and C.C No 1152 dt 02.04.24) I was engaged in checking of sand or other minerals loaded vehicle through WBMDTCL App as per order of superior at different strategic location under Bishnupur Jurisdiction. At about 09:50 hrs near Berai More on Garbeta Bound NH 60 I stopped the aforesaid number vehicle loaded with sand which was coming from Onda Side and found that there was two person present in the truck one Mokibul Islam ( driver ) and other is Barkatulla Bhangi ( Helper). I asked them to produce the valid sand challan in respect of truck bearing No WB33A6427 . But they failed to produce any valid challan. On being asked they informed that they have carrying the sand loaded truck without any challan. Accordingly I searched the truck and found that the truck is loaded with sand. Thereafter I asked the driver of the truck to produced valid documents in respect of the loaded sand. But he failed to produce any such valid documents in support of the loaded sand and neither he nor his helper give any satisfactory account in this regard . Then I arrested them and informed them regarding their ground of arrest and issued memo of arrest after maintaining all the legal formalities of apex court.

So far it is evidently established that the accused driver namely Mokibul Islam and helper Barkatulla Bhangi transporting stolen sand and selling the same illegally. They stated that the owner of the said truck with others involved in this crime since long. There after I seized the



above mentioned truck loaded with the sand under proper seizure list from the possession of the driver of vehicle namely Mokibul Islam between 10:15 hrs to 10:35 hrs.

Under the above fact and circumstances I therefore pray that a specific case may kindly be started under proper section and law against (1) Mokibul Islam ( 33 yrs ) S/O Mobarak Ali of vill Maheshpur Post Maheshpur Murakata , PS Chandrakona Town Dist Paschim Medinipur (Driver of Tata Motors Goods carrier truck bearing no WB33A6427 , Chassis No 426031HRZ014941 and Engine No 80H62701467) ( 2 ) Barkatulla Bhangi ( 23 yrs ) S/O Najimuddin Bhangi of vill Maheshpur Post Maheshpur Murakata , PS Chandrakona Town Dist Paschim Medinipur (Helper of Tata Motors Goods carrier truck bearing no WB33A6427 , Chassis No 426031HRZ014941 and Engine No 80H62701467) and (3) Owner of Tata Motors Goods carrier truck bearing no WB33A6427 , Chassis No 426031HRZ014941 and Engine No 80H62701467 and others and arranged for its investigation and obliged.
