Sub:- Prayer for lodging FIR against accused person namely Biswajit Pal (43 Yrs) S/o Lt. Subhas Pal of Vill Madhabpur Palpara, P.S Barjora, Dist Bankura for illegal storing and selling of liquor under proper section of law.

Respected Sir,

In producing herewith the arrested accused person namely Biswajit Pal (43 Yrs) S/o Lt. Subhas Pal of Vill Madhabpur Palpara, P.S Barjora, Dist Bankura with the following seized articles viz. 20 (twenty) bottles of country spirit measure 600 ml each in sealed condition styled as CAPTAIN STRENGTH 60 UP, IFB Agro Industries Limited (MRP Rs. 155/- each). I ASI Rabin Sarkhel do hereby lodge a written complaint against Biswajit Pal (43 Yrs) S/o Lt. Subhas Pal of Vill Madhabpur Palpara, P.S Barjora, Dist Bankura to the effect that today i.e on 16.04.2024 while performing Special Mobile Duty (vide Maliara O.P under Barjora PS GDE No. 283 dated 16.04.2024) at about 20:25 hrs received a credible information from reliable source that one Biswajit Pal (43 Yrs) S/o Lt. Subhas Pal of Vill Madhabpur Palpara, P.S Barjora, Dist Bankura is selling liquor illegal in exchange of money from his house at Madhabpur Palpara under Barjora P.S. After receiving this information I informed the matter to I/C Barjora P.S and as per his kind direction I along with my accompanying force C/548 Netai Mondal, C/514 Ranjit Kuiry and NVF319 Uttam Mahato proceeded towards Madhabpur village under Barjora P.S to work out the information. At about 20:45 hrs I along with force reached at Madhabpur village and found that said person was storing and selling liquor in exchange of money from his house at Madhabpur. Some people who were present for purchasing liquor fled away after seeing the police in uniform. On seeing the police party the seller also tried to flee away but I along with force managed to apprehend him. On interrogation he disclosed his name as Biswajit Pal (43 Yrs) S/o Lt. Subhas Pal of Vill Madhabpur Pal Para, P.S Barjora, Dist Bankura. I asked him to produce any valid documents in respect of such amount of Liquor in his possession but he could not produce any valid documents. On being further interrogation he stated that he stores liquor and sells these in exchange of money illegally since long. As such, I seized the following articles from the exclusive possession of Biswajit Pal after preparing proper seizure list duly signed by the witness in between 20:55 hrs and 21:15 hrs and labeled properly on the samples. No public witness agreed to sign in the seizure list. So, I took signature of my accompanying police personnel in the seizure list and arrested him by issuing Memo of Arrest after observing all legal formalities regarding arrest, orders of honorable Apex Court and guidelines of N.H.R.C. I collected sample from the following seized items and labeled these properly in presence of witnesses as noted below:-
