Respected Sir.

In producing here with the two arrested accd namely (1) Subal Biswas (32 Y) S/o. Subhash Biswas and (2) Shankar Barui (38Y), S/o. Late Jiten Barui both of Subhashpolly, PS-Bishnupur, Dist-Bankura along with seized 02 engine van loaded with 22 sand bags in each with seizure list. I SI Bahadur Lai of Bishnupur PS lodged complaint as suo-moto that 07/08.04.2024 night at about 05:45 hours on 08.04.2024 while performing Jungle Night Mobile duty (vide Bishnupur PS GDE No 415 dt 07.04.24 and C.C No 1239 dt 07.04.24) at Gossainpur More under Bishnupur PS found that two improvised engine van were coming from Chakdaha side loaded with sand loaded bags. I along with force stopped the said two improvised engine vans asked them to produce the valid sand challan/documents in respect of their sand loaded engine vans. But they failed to produce any valid challan/documents. On being asked they informed that they have carrying the sand loaded engine van without any challan/documents. They did not gave any satisfactory answer in this regard. Then I arrested them after issuing check list and informed them regarding their ground of arrest and issued memo of arrest after maintaining all the legal formalities of apex court. So far it is evidently established that the accused drivers namely Subal Biswas and Shankar Barui transporting stolen sand and selling the same illegally. There after I seized the 02 improvised engine vans loaded 22 sand bags each under proper seizure list from the exclusive possessions of the drivers in between 06:15 hours to 06:35 hours.

Under the above fact and circumstances I pray before you that a specific case may kindly be started under proper section and law against (1) Subal Biswas (32 Y) S/o. Subhash Biswas and (2) Shankar Barui (38Y),S/o. Late Jiten Barui both of Subhashpolly, PS-Bishnupur, Dist-Bankura and arranged for its investigation and obliged.
