Sub:- Prayer for lodging specific case as per section of law.

Sir,

In producing herewith the persons namely 1)Anath Bandhu Mandal S/o Lt Gobinda Chandra Mandal and 2) Sandhya Sau D/o Kanailal Jana, I LSI Saswati Maity of Bishnupur P.S., beg to state that today (17.04.2024) as per information received from duty officer that one severe quarrelling and beating to each other is happening from few hours, and any incident of murder may be happened, at one of the houses in Bhagabati Mill campus, at Bishnupur Jhapor Morh. As per information from duty officer and taking permission from I/C Bishnupur sir; I with my accompanied force moved to the mentioned place, at Jhapor Morh, Bishnupur.On arrival there, I saw that a hot altercation and scuffling has been going on in between the two persons (as noted above), and both of them with sharp iron made tools are trying to assault each other.

On preliminary enquiry, from both sides, it is revealed that the house is of Anath Bandhu Mandal, who presently resides at Kalikapur Road, Mukundpur, South 24Parganas. He came to his present residential house at Jhapor Morh, and asked the said Sandhya Sau to leave his house. Whereas, said Sandhya Sau D/o Kanailal Jana claimed that she will not leave the house any more, as the person committed physical relation with her, and made an agreement. In present circumstances, both of them are seen in aggressive mood and assaulting each other. In present of police party, both of them, with iron made tools are about to throw each other. I with my accompanied force, tried our best to soothe both of them, considering their age. But we failed to restrain them.

Said Anath Bandhu Mandal stated that this is his house, and Sandhya Sau should leave his house immediately. Vis-à-vis, said Sandhya Sau claimed thatshe will not leave the house anymore, as it was a previous bond to each other. Both of them are in approaching with each other to kill, with dire consequences. In this situation, I with my accompanied police team tried our best to mitigate the situation, but finding no other alternative, and also to prevent any cognizable offence, I took both them in custody and arrested them U/s 151 CrPC. Put signature both of them in Arrest memo and check list, and briefed them the ground of their arrest.

Hence, I pray before you, necessary legal action may kindly be initiated, and registered specific case as per law against both of the persons.
