

Sub : Prayer for taking necessary steps regarding some vulgar, sexually explicit comments from some Facebook profile against the post inside the "Dil Khan Fan Club" by some "Aryan Sanatan" with an intension of defaming the chair of the Superintendent, Bishnupur District Hospital and with an aim of provocation for physical attack.

Sir,

As you know that, some "Aryan Sanatan" is continuously uploading different ill, distorted and provocative posts in the social media/facebook (same post to approx 60 different facebook groups of seven districts, like-Bankura, Hooghly, Howrah, East Midnapore, Kolkata, East Burdwan, Jhargram) for two months with an intension of defamation of the chair of the superintendent and publication in electronic social media containing sexually explicit and vulgar and with intension of physical attack to the undersigned personally.

I had submitted a written complain at your Bishnupur P.S on 21/03/24 and a GDE no (1387) was issued from your end on 21/03/24.

I would like to bring your kind notice that against one such post inside Dil Khan Fan Club facebook group (having link of <https://www.facebook.com/groups/274567687512249>) on 11.04.2024 to 12.04.2024 following vulgar, sexual explicit comments have been posted in public forum inside Facebook.-

"Khankir chala subhankar koyel ka hatao na hole bishnupur hospital ka khatam kore dibe" & "koti koti taka kamacha magibagi sura pan korcha" above comment was posted from Facebook profile "Paritosh Nandi".
