Sir.

In producing here with one accused person namely Dinesh Gorai (30 Years approx.), S/o- Dulal Gorai of Vill- Shyampur, PS-Saltora, Dist-Bankura under arrest and seized one stone chips loaded Dumper having Registration No:- WB 67B 4666 under seizure list enclosed here with.

I do here by lodge this complaint regarding that today 25.04.2024 at about 16:15 hrs during my NAKA checking duty Vide Indpur PS C.C. No- 730/24 and GDE No- 802 both dated-25.04.2024 at Bhutargora Naka Check Post under Indpur PS received a credible source information about one stone chips loaded vehicle was coming towards Pairachali Bazar from Bankura side through Bankura-Purulia NH-60A road without a valid challan. Immediately, I along with force rushed towards Pairachali Bazar and found one stone chips loaded vehicle (Dumper) having Registration No- WB67B/4666 near Pairachali Petrol Pump (Bharat Petroleum) under Indpur P.S. and detained the vehicle for checking. On demand the driver of the vehicle could not able to produce the proper chalan of loaded stone chips on that vehicle. On interrogation the driver of above noted vehicle stated that he has stolen the stone chips from the Saltora mining under Saltora PS to dispose it clandestinely for illegal gain. Detained the vehicle and informed to OC Indpur PS and as per his kind instruction I have seized the above noted vehicle (Dumper) having registration No: - WB67B/4666 loaded with stone chips in between 17:05 hrs to 17:25 hrs on 25.04.2024 under proper seizure list duly signed by the witnesses. Then arrested the accused driver after maintaining the all legal formalities as prescribed by apex court and NHRC guideline. Thereafter, I brought the accused driver along with seized vehicle to Indpur PS and submitted complaint as sou-moto to this PS.

Under the above fact on study of circumstances it is evidently established that the above noted accused person have virtually committed offence which is punishable U/S-379/411 I.P.C. and Section 21 of Mines and Minerals (Development and Regulation) Act, 1957.
