In reference to the above this is to inform him that Santanu Mallick, proprietor of Quality Sweets, Khatra was entrusted with supplying of tiffin packets for Polling Personnels taking their training i.e.w Parliament General Election-2024 on 20/04/2024 in two venues i.e. at Kangsaati Sishu Vidyalaya, Khatra and Khatra Girls' High School. Packets as supplied has been found to be totally unhygienic coupled with food stuff beyond expiry date. The Polling Personnels who took the packet agitated against such unhygienic supply of food stuff. There was every possibility of serious threat to the health of the Polling Personnels who were being imparted training programme for the upcoming Parliament General Election-2024

In context of the above, you are requested to treat this letter as an FIR against Santanu Mallick, Proprietor of Quality Sweets, Khatra and take immediate action against him as per law.


