

Sub: Prayer to start FIR against arrested accused namely Basudeb Adhikari (59) s/o Lt. Prahlad Adhikari of vill-Chatra, PS- Kotulpur, Dist- Bankura
Sir,

With due respect and humble submission I beg to state that I SI Subir Pati of Kotulpur PS, District- Bankura do hereby lodge this complaint to the effect that today i.e. on 23.04.2024 at about 14.05 hrs. received a source information that one person selling I/D Liquor road side of Kuntalbazar village without having any license of competent authority. After that as per order I SI Subir Pati along with accompanied force namely C/1101 Chandan Kr. Biswas, NVF 15120597 Asit Patra all of Kotulpur PS (vide CC No.1041/24 dt.- 23.04.2024) with proper uniform by Govt. vehicle and with I.O's kit containing white paper, carbon, gala, seal, wax, white markin, Match box, candles etc. While we reached at road side of Kuntalbazar village and found that one person containing ID Liquor road side of Kuntalbazar village. Questioning him about the Liquor but he stated nothing. We detained the person & gave our identity to him as Police personnel of Kotulpur PS. We, the Police personnel offered him to search our persons before we start searching, but he told that he will not search our persons. During search in between 14:45 hrs to 15:05 hrs some container of I/D liquors and some articles were found. The description of the ID Liquors and articles are found from his tailor shop premises are given below:

1. Three white colour Plastic Jariken each contained 10 (ten) Litters of I.D. liquor
2. 25 (Twenty five) numbers of plastic glasses.

During interrogation the accused namely Basudeb Adhikari (59) s/o Lt. Prahlad Adhikari of vill- Chatra,, PS- Kotulpur, Dist- Bankura confessed that he selling ID liquor road side of Kuntalbazar village but he has no license to selling of ID liquors. So I seized the above noted ID liquors from his possession. Seizure is done under proper seizure list duly signed by the witnesses and I offer available local people to sign the seizure list but they are not turned up. I have sealed and labeled of above noted jariken and articles. Accordingly I arrested him under maintaining all the legal formalities.

I therefore pray that a specific case may kindly be started against him for proper investigation as he has committed an offence under the provision of Bengal Excise Act.
