**Sub:- Prayer for lodging FIR against Dulal Maji (approx. 48 Years), S/O- Rabilochan Maji of Village-Duburia, P.S- Mejia, District- Bankura.**

Sir,

In producing herewith the arrested accused person namely Dulal Maji (approx. 48 Years), S/O- Rabilochan Maji of Village-Duburia, P.S- Mejia, District- Bankura. along with seized articles (1) 18 (Eighteen) bottles of Country Spirit styled as Captain containing 375 ml each, MRP- RS 95/- per bottle, (2) One bottle of Country Spirit styled as Captain containing 375 ml, MRP- RS 95/- collected as sample from SL No- 1 and duly sealed and labeled by me I, ASI Kalyan Prasad Sinha S/o Bhujanga Bhusan Sinha of Mejia P.S do hereby lodge complaint against one Dulal Maji (approx. 48 Years), S/O- Rabilochan Maji of Village-Duburia, P.S- Mejia, District- Bankura. to the effect that today i.e. on 29.03.2024 at about 05:25 hours in course of my night mobile duty vide Mejia P.S G.D.E. no-1658 Dt -28.03.2024 & C.C No- 1004, received secret source information over phone that illegal sale of Country Spirit is going on at Duburia village at the house of Dulal Maji. Accordingly, I informed the matter to O/C, Mejia P.S over phone and as per his kind permission, I along with my accompanying force namely C/2664-Sanjoy Kr Maji, NVF/0466- Rajib Chakraborty & HG/BKL-07 Ajit Kari left for Duburia village to work out the information.

On 29.03.2024 at about 06:15 hours, I along with my accompanying force reached at Duburia village at the house of Dulal Maji and found some persons who were taking liquor from Dulal Maji started to flee away. We chased them, but we could manage to detain one person. On being asked, he disclosed his identity as Dulal Maji (approx. 48 Years), S/O- Rabilochan Maji of Village-Duburia, P.S- Mejia, District- Bankura. I called some disinterested persons. In presence of some local people and police personnel searched the house of the detained person and found **18 (Eighteen) bottles of Country Spirit styled as Captain containing 375 ml each, MRP- RS 95/- per bottle.** On local enquiry, I came to learn that the apprehended person used to sell liquor illegally from his house and he is running this illegal business since long with a view to his wrongful gain. On being asked he failed to produce any valid documents in respect of the storing and selling of Country spirit. So I seized the same in presence of witnesses arranged to collect one bottle as sample, sealed and labeled the same. On several request, no local people came forward to sign the seizure list. Hence, finding no other alternatives, I took signature of my accompanying force namely C/2664-Sanjoy Kr Maji, NVF/0466- Rajib Chakraborty & HG/BKL-07 Ajit Kari all of Mejia P.S on the seizure list as seizure witnesses. The seizure of the above articles was made in between 06:25 to 06:35 hrs and copy of seizure list has been provided to the detained person. Thereafter I arrest the accused person namely Dulal Maji (approx. 48 Years), S/O- Rabilochan Maji of Village-Duburia, P.S- Mejia, District- Bankura. The approximate value of the article seized is Rs. 1710/- only.

I, therefore, pray before your kind self that a specific case may kindly be registered against the accused person namely Dulal Maji (approx. 48 Years), S/O- Rabilochan Maji of Village-Duburia, P.S- Mejia, District- Bankura. under proper section of law and arrange for its investigation.
