Subject:- Prayer for lodging FIR against arrested accused persons namely 1) Ganesh Nekra @ Putu (34) S/o- Bhiku Nekra of Village- Mochrakendra, P.S- Mejia, District-Bankura.2)Ujjal Bauri (35) S/o- Gurupada Bauri of Vill- Bharra, P.S- Mejia, District-Bankura.

Respected Sir,

In producing herewith two arrested accused persons along with seized articles viz

(1) One country made Iron Body wooden butt small fire arms with barrel having approx. length 14 cm, wooden butt having approx. length 7.5 cm, fitted with trigger, hammer and spring loaded with One round 08 MM live ammunition styled as KF which was kept in the exclusive possession of Ganesh Nekra @ Putu (34) S/o- Bhiku Nekra of Village- Mochrakendra, P.S- Mejia, District-Bankura, and (2) Two rounds of 08 MM live ammunition styled as KF covered by a yellow colour poly bag which was kept in the exclusive possession of the arrested accused namely Ujjal Bauri (35) S/o- Gurupada Bauri of Vill- Bharra, P.S- Mejia, District-Bankura under proper seizure list and label, I ASI Achintya Kr Das of Mejia PS beg to inform that today i.e. on 31.03.2024 at about 20:05 hours, while myself along with force were performing Mobile duty in proper Police uniform at Mejia Mejia P.S area vide Mejia PS C.C No-1132 dtd. 31.03.2024 & GDE No- 1765 dtd. 31.03.2024 and received a reliable source information that some persons were coming near at Telenda Ambagan under Ramchandrapur GP area to supply Arms and ammunition to some unknown persons. Accordingly I informed the matter to O/C Mejia PS, and as per his direction myself along with force left for Telenda Ambagan under Ramchandrapur GP area to work out the information. After arrival myself along with force cordoning the place and waited for the miscreants. After few time at about 20:45 hrs we found two suspicious persons were coming from Ramchandrapur side towards Telenda side. We tried to detain them but seeing us in Police uniform they had started fleeing away from the spot. On suspicion, I along with my Police party chased them and after a short chase, we could somehow manage to surround them and apprehend them. I offered them our search but he refused. Thereafter, I searched them thoroughly, and found One country made Iron Body wooden butt small fire arms with barrel having approx. length 14 cm, wooden butt having approx. length 7.5 cm, fitted with trigger, hammer and spring loaded with One round 08 MM live ammunition styled as KF which was kept in the exclusive possession of the Arrested accused namely Ganesh Nekra @ Putu (34) S/o- Bhiku Nekra of Village- Mochrakendra, P.S- Mejia, District-Bankura and Two rounds of 08 MM live ammunition styled as KF covered by a yellow colour poly bag which was kept in the exclusive possession of the arrested accused namely Ujjal Bauri (35) S/o- Gurupada Bauri of Vill- Bharra, P.S- Mejia, District-Bankura. On demand they failed to produce any license or valid documents in favour of the said firearms and ammunitions nor could justified the procurement of the same. Accordingly, I seized One country made Iron Body wooden butt small fire arms with barrel having approx. length 14 cm, wooden butt having approx. length 7.5 cm, fitted with trigger, hammer and spring loaded with One round 08 MM live ammunition styled as KF which from the exclusive possession of Ganesh Nekra @ Putu (34) S/o- Bhiku Nekra of Village- Mochrakendra, P.S- Mejia, District-Bankura, and Two rounds of 08 MM live ammunition styled as KF covered by a yellow colour poly bag from the exclusive possession of Ujjal Bauri (35) S/o- Gurupada Bauri of Vill- Bharra, P.S- Mejia, District-Bankura under proper seizure list duly seized by me followed by labeling in presence of Police witnesses and signed by the accused persons due to non-availability of public witnesses at that time. I read it over to them in

Bengali language and obtained the signature of the accused person as well as my accompanying force on the seizure list & label, also supplied copies of seizure list to Ganesh Nekra @ Putu (34) S/o- Bhiku Nekra of Village- Mochrakendra, P.S- Mejia, District-Bankura and Ujjal Bauri (35) S/o- Gurupada Bauri of Vill- Bharra, P.S- Mejia, District-Bankura. After that I interrogated them thoroughly and they confessed that they are the supplier of Arms and ammunition, and they were gathered there with the intention of dealing of Fire arms and ammunition to some unknown miscreants.

Thereafter, following all the legal formalities, I arrested the accused persons as there has been every reason to believe that they had procured the said fire arms with the live ammunitions illegally without any valid documents to use and supply the same for their ulterior motive. I returned to PS with them along with the seized articles.

Under the above fact & circumstances, I, pray before your kind self that a specific case may kindly be started against the arrested accused persons namely 1) Ganesh Nekra @ Putu (34) S/o- Bhiku Nekra of Village- Mochrakendra, P.S- Mejia, District-Bankura. 2) Ujjal Bauri (35) S/o- Gurupada Bauri of Vill- Bharra, P.S- Mejia, District-Bankura under proper section of law and arrange for its investigation.
