Sub:- Complaint against of accused namely Silu Mal (M/35 yrs) S/O-Lt. Rasik Mal of Vill-Kalyani, PO-Hirapur, PS-Onda, Dist-Bankura for illegal selling of Liquor.

Sir,

In producing herewith with the arrested accused person namely Silu Mal (M/35 yrs) S/O-Lt. Rasik Mal of Vill-Kalyani, PO-Hirapur, PS-Onda, Dist-Bankura along with seized articles as per seizure list I beg to submit that on 31.03.2024, during my mobile duty, I, ASI Jayanta Mondal of Punisole OP under Onda PS received a source information that one Silu Mal (M/35 yrs) S/O-Lt. Rasik Mal of Vill-Kalyani, PO-Hirapur, PS-Onda, Dist-Bankura is illegally selling I/D liquor at Kalyani village under Onda PS. Accordingly, I inform the matter IC Punisole OP and as per his direction I ASI Jayanta Mondal of Punisole OP under Onda PS along with C/1359 Sandip Mondal, NVF/0706 Goutam Panda, NVF/0143 Sandip Kr. Mahata vide CC No. 178/2024, dt 31.03.2024 proceeded to Kalyani village to work out the information. At about 22:35, hrs we reached at Kalyani village and saw that the said person is selling I/D liquor in lieu of money upon some customers. Seeing Police party, he tried to flew away from the spot with the customers. Myself along with my accompanying force succeeded to apprehend him. In presence of other witnesses, I searched surrounding places and found 20 Ltrs of I/D liquor kept in a white plastic jerakin. During local enquiry it could be learnt that, the above noted person continuing his business without any valid license or valid papers. Accordingly, I seized the said articles under proper seizure list followed by proper sealing & labeling duly signed by the witnesses and one 350 ml $\ensuremath{\mathrm{I/D}}$ liquor of noted seized articles collected as "Sample" and arrested the above noted accused person informing him the ground of arrest maintaining all NHRC guidelines. As the said person namely Silu Mal (M/35 yrs) S/O-Lt. Rasik Mal of Vill-Kalyani, PO-Hirapur, PS-Onda, Dist-Bankura have committed the offence which attracts sec. 46 (b) of Bengal Excise Act 1909.

Therefore, I pray that necessary steps may kindly be taken against accused person namely Silu Mal (M/35 yrs) S/O-Lt. Rasik Mal of Vill-Kalyani, PO-Hirapur, PS-Onda, Dist-Bankura under proper section of law.
