In producing herewith seized article i.e. (1) 05 (five) plastic made containers, out of 05 (five) plastic made containers 04 (four) loaded with approx 05 (five) litters & another loaded with approx 04 (four) litters liquid appearing to have been illicit liquor after collecting sample in a (2) one 600 ML plastic bottle loaded with approx 550 ml liquid from the seized container. (3) Some plastic glass & (4) one funnel from the premises of Bubai Majhi under seizure, seizure list. I, do hereby submit complaint against accused Bubai Majhi S/O Lt. Hriday Majhi of Vill- Machatora(Mandalpara), P.O-Machatora, P.S-Simlapal, Dist-Bankura to the effect that on 05.04.24 at about 10:15 hrs as per source information I along with force held raid at Machatora (Mandalpara) village, P.O- Machatora, P.S-Simlapal house premises of Bubai Majhi S/O Lt. Hriday Majhi and found that above noted Bubai Majhi was selling illicit liquor in a polithin glass from a plastic container. On seeing Police party he fled away and managed to conceal himself behind a bush. The raid team found I/D liquor and other related articles in the house premises of above noted Bubai Majhi which was possessed and getting sold illegally. So, I seized the following articles in between 11:15 hrs to 12:25 hrs (1) 05 (five) plastic made containers, out of 05 (five) plastic made containers 04 (four) loaded with approx 05 (five) litters & another loaded with approx 04 (four) litters liquid appearing to have been illicit liquor after collecting sample in a (2) one 600 ML plastic bottle loaded with approx 550 ml liquid from the seized container. (3) Some plastic glass & (4) one funnel from the premises of Bubai Majhi under proper seizure list as alamat.

So, I pray before you to start a case under proper section of law against accused Bubai Majhi S/O Lt. Hriday Majhi of Vill- Machatora(Mandalpara), P.O-Machatora, P.S-Simlapal, Dist-Bankura and arrange for its investigation.
