 And their marriage was Registered on 10/01/23 before
 Marriage officer - Nirmalya Roy.
 2 No. Accused is the father in Law, 3 No. Accused is
 Mother in Law, 4 No. is Debar (Husband's brother)
 5 No. Accused is Ringmaster (relatives 6 to 7 are
 Relatives of other Accuseds.)
 The Complainant's father Madan Kirtaniya gave
 Cash of Rs one Lakh, 05 Bhookies of golden ornaments
 nts, Dera, dressing table etc and other utensils
 as per demand of Accused No. 1 and his
 family inmates. The Complainant and Accused
 No. 1. have a minor son Satwik Mishra aged
 about 08 months.

A few days later of their marriage All the Above noted
 Accuseds Extra demanded of Rs one Lakh for
 Business purpose of Accused No. 1.
 All the accuseds Creating pressure upon the complain-
 ant to bring their extra demand from the father.

Father of the Complainant. But when she -
disagreed to bring them all the Accuseds made
different kinds of physical and mental torture
upon the Complainant -

Sublime it to say, that on 13/02/24 Night the
Accuseds persons preplanning wanted to Kill the
Complainant by poisoning with the food of
Complainant but in vain.
The Complainant did not take any food
on that night and informed the matter to
her parent by telephone.

Then all the accuseds jointly assaulted the
Complainant, mercilessly beaten and Next
Morning on 14/02/24 snatching all ornaments drove
her out from matrimonial home with her minor
son wearing a single cloth. The Complainant
took shelter to her father's rented house at
Shankaribazar Bishnupur.

Thinking the future life of Complainant
and her minor son she did not lodged
any complain to any places.

There after on 23/04/2024 at about 12 to 12-30
noon all the above noted Accuseds riding on
a Maruti Car came to Bishnupur Shankaribazar
where the Complainant and her parent resided
in a rented house that house is the Accuseds
Relative. All the Accused entering in that
house assaulted the Complainant and snatching
Rs 5,000/- (Rs Five thousand only) which was in
the money bag of the Complainant that money
was kept for feeding of her minor son.
The Complainant was sitting over the floor
taking minor son in her lap and money bag
was in the hands of the Complainant.
Accused No. 1. Assaulted her and taken
away the money bag.

The Next day on 24/04/24 she was medically
treated at Bishnupur S.D. Hospital.
