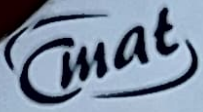

Dear Sir,

In reference to the above subject, we would like to inform you that a highly unfortunate incident has occurred in our site. You are aware that we are being entrusted with the construction of Shali Bridge works from PWD(NH) department, West Bengal.

Yesterday around 03.30 pm we were plying our empty dumpers from the borrow pit at village Konro. Few people gathered and brutally assaulted our dumper driver & excavator operator, Pappu Yadav & Chandan Singh respectively. The assault was so deadly that Chandan (Excavator Operator) was admitted at Bankura Medical College. Those assaulters were from village Konra or Pabradihi.

In view of above, We would request you to kindly investigate the matter and take necessary action from your end. We fear that these people may again harm.
