Sir,

In producing herewith accused Subrata Das (25yrs) S/o Gurupada Das of Dharramouli, P.S-Khatra, Dist-Bankura along with seized articles e.g total 18 bottles of liquor of different quantity and different company e.g 12 (500ml each) container of Kingfisher Strong Premium Beer, 2 bottle (375ml each) McDowell's Rum, 2 bottle (180ml each) McDowell's Rum, 2 bottle (180ml each) Officer's Choice, I, SI Sanjay Senapati, I beg to submit that on 06.05.24 at about 20.20 hours while myself along with force was performing special mobile duty at Supur Crossing I received an information that one Subrata Das was selling liquor illegally at Dharramouli village under P5 Khatra from his grocery shop. After receiving this information I went at Dharramouli and I arrived there at about 20.45 hours. My Source identified a shop and I found that one person was selling liquor to 3-4 persons from the shop. When I proceeded towards them, seeing the police party, all of them started to flee away but I managed to apprehend the seller. On being asked he disclosed his identity as Subrata Das (25yrs) S/o Gurupada Das of Dharramouli, P.S-Khatra, Dist-Bankura. He further confessed that he was selling liquor from there. On further examination he had shown a bag inside the shop and after searching that total 18 bottles of liquor of different quantity and different company e.g 12 (500ml each) container of Kingfisher Strong Premium Beer, 2 bottle (375ml each) McDowell's Rum, 2 bottle (180ml each) McDowell's Rum, 2 bottle (180ml each) Officer's Choice were recovered from that bag. On being asked he failed to produce any valid document in support of his possessing and selling of above mentioned recovered liquor. Then I seized those recovered liquor along with the bag under proper seizure list. The seizure was done in between 21.05 hours (06.05.24) to 21.45 hours. I arrested Subrata Das for illegally possessing and selling liquor.

So I pray before you that specific case may kindly be started against Subrata Das (25yrs) S/o Gurupada Das of Dharramouli, P.S-Khatra, Dist-Bankura for possessing and selling liquor illegally.
