Complaint Under Section 156 (3) Cr PC against above named accused persons

The complainant most respectfully begs to state following:

That accused person Parseh Dutta S/O Late Kinkar Dutta resident at Madhabganj, Borom tola, Ward No: 10, Post & Ps: Bishnupur, District: Bankura, Pin: 722122 and then the BL&LRO, Bishnupur had hatched a conspiracy to hush up valuable property of complainant lying under Bishnupur Municipality Mouza, JL, No: 101, LR Khatian No: 17676, LR Plot no: 4278, corresponding RS Plot No: 3692, 3693 measuring 0.0120 acre out of total 0.0200 acre which has been illegally reduced to 0.0034 acre on the basis of a fake and manufactured registered deed being no: 545 deed dated 15/06/1981, registered with the office at ADSRO, Bishnupur, District: Bankura, by misusing process of law, misusing public office and under the garb of being public servant in the case no: MN/2023/0117/2300, Mutation of land under section 50 of WBLR Act 1955, order dated 17/04/2023, without serving any notice upon the complainant or giving any opportunity to the complainant. Be it noted no such plot number is there in the said impugned deed nor Mouza of Bishnupur Municipality found mentioned in the deed basing upon which cheat, forgery of public register or record of BL&LRO, Bishnupur, forgery for purpose of cheating, making a false document and others.. Despite all then the BL&LRO, Bishnupur by misusing his power, public office joined hands

with Parseh Dutta S/O Late Kinkar Dutta resident at Madhabganj, Borom tola, Ward No: 10, Post & Ps: Bishnupur, District: Bankura, Pin: 722122 committed Cheat, forgery of public register or record of BL&LRO, Bishnupur, forgery for purpose of cheating, making a false document and others. Furthermore, neither Paresh Dutta had purchased through said impugned deed being no 545 nor had inherited anything from said deed nor LR Plot no: 4278, corresponding RS Plot No: 3692, 3693 total 0.0200, under Bishnupur Municipality Mouza was subject of said impugned deed. Complainant had lodged complaint with the I.C. Bishnupur Police Station against them who had neither investigated nor had admitted complaint against them. Furthermore, the complainant had also approached with then the SDPO, Bishnupur against accused persons for cheat, forgery of public register or record of BL&LRO, Bishnupur, forgery for purpose of cheating, making a false document and others. Aggrieved by the modus operandi of I.C. Bishnupur Police Station with the complaint, the complainant had preferred to send copy of complaint to Superintendent Of Police Bankura and Inspector-in-charge, Bishnupur through registered post with acknowledgement due. Apart from that the complainant had also sent an application with the District Magistrate, Bankura for sanction for filing one FIR against then the BL&LRO, Bishnupur under section 197 Cr PC.

**Prayer**

Hence it is most graciously being prayed that your Honor may be pleased to pass an order of investigation to Inspector-in-charge, Bishnupur Police Station under section 156 (3) Cr PC of this complaint to bring those culprits or accused persons and others under justice for involvement with the commission of cheat, forgery of public register or record of BL&LRO, Bishnupur, forgery for purpose of cheating, making a false document and others and punish them. Photo copy of order sheet, copy of sanction under section 197 Cr PC and said impugned deed is appended herewith.
