Sub:- Prayer for starting a specific case.

Sir,

In producing here with one accused person named kartick Bauri (22yrs), S/O- Sital Bauri of Vill-Balarampur, PO- Akhrasole, PS-Patrasayer, Dist-Bankura under arrest and seized one tractor bearing registration no WB88C/6964 along with sand loaded trolley and seizure list enclosed here with.

I do here by lodge this complaint regarding that today ( 03.05.24 ) at about 13.10 hrs during area patrolling duty Vide Radhanagar Out Post C.C. No-298/24 date-03.05.24 and GDE No- 61 Date-03.05.24. received secret source information that one tractor was coming towards Patrasayer Morh side from Hingjuri Morh side under Bishnupur P.S loaded with sand without proper challan or valid document. Accordingly, after obtaining kind permission of I.C. Bishnupur P.S, I along with force went towards Hingjuri Morh and on the way near Dejhat village Morh on Joykrishnapur- Patrasayer road under Bishnupur PS area found the above noted tractor is coming towards Patrasayer Morh side. Seeing the Police van, the driver of the tractor stopped his vehicle and started to flee away leaving behind his tractor on the road. I along with accompanied force in suspicion chased him, and could apprehend the driver named Kartick Bauri. I interrogated the accused driver and came to learn that he is the driver of sand loaded tractor bearing no WB88C/6964. On demand he could produce neither any challan nor valid document nor could give any satisfactory answer in respect of the sand loaded trolley attached with his tractor.

He often gave incoherent statements as sometimes stated that he loaded the sand from Jujur Bali Ghat and sometimes stated that loaded the sand from Narangi Bali Ghat under Patrasayer PS. I also came to learn that tractor owner is involved in operating the process of illegal sand loading. From the statement it is revealed that the driver along with the owner of the Tractor Rohit Shit of Vill- Balarampur, PO- Akhrasole, PS- Patrasayer Dist- Bankura, operating/transporting/selling this illegal business since long in clandestine manner.

Under the above fact & circumstances, in suspicion of stolen property, I seized the above noted tractor bearing registration no WB 88C/6964 attached with sand loaded trolley in between 13.20 hrs to 14.05 hrs on 03.05.24 under proper seizure list.

I also arrested the accused driver named kartick Bauri (30yrs), S/O- Sital Bauri of Vill-Balarampur , PO- Akhrasole , PS-Patrasayer, Dist-Bankura after maintaining all legal formalities prescribed by Apex Court and NHRC guide line under Memo of Arrest.

Accordingly, I brought him to Bishnupur PS after keeping the seized vehicle at Radhanagar OP and submitted complaint as sou-moto to this PS.

Under the above fact & circumstances it is evidently established that the accused driver namely kartick Bauri (30yrs), S/O- Sital Bauri of Vill-Balarampur, PO- Akhrasole, PS-Patrasayer, Dist-Bankura and owner of the Tractor namely Rohit Shit of Vill-Balarampur, PO- Akhrasole, PS-Patrasayer, Dist-Bankura have been stealing the sand and transporting & selling the same illegally. Therefore, I pray that specific case may kindly be started under proper section of law against them
