Sir,

In producing herewith arrested accused person namely **Bikash Garai (M/30 Yrs), S/O- Haradhan Garai of vill- Ituri, P.S.- Saltora, Dist- Bankura** along with the seized articles i.e. i) 10 (Ten) bottles of sealed country sprit styled as "CAPTAIN" measuring 600 ml each bottles (600 ml X 10 bottles=6.0 Itrs. MRP Rs- 155/- each bottle total RS- 1550), in which one 01 (one) Bottle collected as sample from those bottles under proper seizure list duly signed by the arrested accused person and the other witnesses.


I, ASI Saroj Kr Panda of Saltora P.S do here by lodge a complaint against him. I beg to state that, on 14.05.2024 at 05:45 hrs in course of night mobile duty vide C.C No- 1141/24 dtd.13.05.2024 received a credible source information that at Ituri Hat Tala under Tiluri GP one person is selling country sprit illegally to the customers in exchange of money. Accordingly I informed the matter to O/C Saltora PS and as per his direction I along with C/1749 Soumen Nandi, and NVF Asit Mondal left for Ituri more to work out the such information.


Thereafter we reached at Ituri Hat tala at 06:15 hrs as per information and found that some persons gathered in the tea shop and found that said tea shop owner was selling the country Sprit from his shop . Seeing the Police vehicle they started to flee away, we chased behind them but all of them managed to escaped only we apprehended the Seller person and he disclosed his identity that namely Bikash Garai (M/30 Yrs), S/O- Haradhan Garai of vill- Ituri, P.S.- Saltora, Dist- Bankura. I along with force searched into the said tea shop of accused person and found i) 10 (Ten) bottles of sealed country sprit styled as "CAPTAIN" measuring 600 ml each bottles (600 ml X 10 bottles=6.0 Itrs. MRP Rs- 155/- each bottle total RS- 1550). On being asking he could not be produces any valid license and he illegally selling country sprit. I asked him to produce valid papers against selling the country sprit to the customer but he failed to produce any valid papers. On integration the arrested accrued person admitted that he illegally selling country sprit CAPTAIN from this tea shop to customers with exchange of money for wrongful gain and he is running this illegal business since long. As search I seized above noted articles after preparing proper seizure list duly signed by the witnesses and also collected the sample with proper labeled. Then I arrested him after observing all legal formalities laid down in Cr.P.C and Hon'ble Apex Court.

I therefore pray that a specific case under Bengal Excise Act may kindly be started against accused person namely **Bikash Garai (M/30 Yrs), S/O- Haradhan Garai of vill- Ituri, P.S.- Saltora, Dist- Bankura** and arrange for its investigation.
