Sir



In producing herewith the arrested accused persons namely Somnath Ghosh @ Bubai (33 Yrs) s/o Akul Ghosh of vill- Tilabediya PS & Dist.- Bankura along with seized material seemed to be deisel, total approx 45 litres in two jerricanes,01 red coloured funnel ,01 plastic chungi to the effect that today on 20.06.24 at 10:05 hrs received a source information that illegal selling of diesel is running at a hotel locally known as Bubai Hotel at Tilabediya more under Bankura PS and accordingly with kind permission of superiors, myself along with SI Sadhan Singha Mahapatra ,C/ 46 Pralay Kumar Mandal ,C/740 Ram Prasad Roy, C/127 Angshuman Sahana being accompanied by Insp. DEB, Bankura vide Bankura PS GDE No 1008 dated 20.06.24 left for the place with Govt Vehicle No. WB68AA/0047 assisted by Bankura PS mobile van officer ASI Buddhadeb Nandi with force.

At about 12:15 hrs we arrived at Tilabediya more, cordoned the hotel locally known as Bubai Hotel of above noted person as identified by the source and apprehended the above noted person. On being asked the arrested person stated that he illegally collect the diesel oil from the ongoing trucks at kept the said oil at his hotel near Tilabediya More under Bankura PS with a view to deliver it to the shops or passer by at Kanchanpur area for disposal. On being verification he failed to produce any valid documents in respect of said oil.

On interrogation accused confessed his guilt and stated that he stored (Huge quantity) at his hotel premises illegally for more profit. Accordingly I seized material seemed to be deisel oil total approx 45 litres in two jerricanes,01 red coloured funnel ,01 plastic chungi with proper seizure list duly sealed and labelled by me in-between 12:35 hrs to 12:55 hrs duly signed by the witnesses and arrested the accused person namely Somnath Ghosh @ Bubai s/o Akul Ghosh of vill- Tilabediya PS & Dist.- Bankura after maintaining all NHRC guideline. A copy of seizure list also handed over to him. I also prayed that the seized articles kept in your PS Malkhana with proper procedure.

During investigation of this case as per confession of accused person and statement of witnesses it was well established that the accused Somnath Ghosh @ Bubai (33 Yrs) s/o Akul Ghosh of vill- Tilabediya PS & Dist.- Bankura stocked the huge quantity of diesel Oil illegally and sale the same for more profit. It also came in to notice that few others persons are also involved in this matter.

It is reasonably believe that the arrested persons and others are procured approx 45 Itrs diesel oil which is suspected to be stolen property. Hence he are liable for prosecution under section 4 of West Bengal Anti Profiteering Act 1958, section 379/411 IPC and section 7(1)(a)(ii) of E.C Act 1955 for procuring, hoarding, supplying, storing and transporting of diesel oil illegally.
