In producing herewith the arrested accused persons namely (1) Avijit Saha (26 Yrs) S/O Lt. Gopal Saha of Vill-Agaya PS & Dist-Bankura (2) Dulal Malla (55 Yrs) S/O Lt. Anil Malla of Vill-Patakola PS & Dist-Bankura (3) Ajoy Mal (25 Yrs) S/O Jiten Mal of Vill-Jamboni PS & Dist-Bankura (4) Sujan Mal (29 Yrs) S/O Jiten Mal of Vill-Jamboni PS & Dist-Bankura and seized 04 nos. Engine van loaded with 25 sack of sand in each engine van along with memo of arrest and seizure list I, ASI Netai Nandi of Bankura PS, do here by lodge written complaint to the effect that today i.e on 06.06.2024 as per your kind order myself along with force were performing mobile patrolling duty in PS area vide Bankura C.C. No. 3006/24 dated 06.06.2024. During mobile duty at about 16:05 hrs while I was passing through Banshi Bridge on Minapur Samsan to Banshi village road, I found that some persons were extracting sand from Darakeswar riverbed and stag at near Minapur Maha Samsan in the sack. I along with force rushed at Minapur Maha Samsan. On seeing the police party, they started to flee away, leaving their 04 nos. Engine van loaded with 25 sack of sand in each engine van. After a hot chase, we managed to apprehend 04 persons who disclosed their identity as (1) Avijit Saha (26 Yrs) S/O Lt. Gopal Saha of Vill-Agaya PS & Dist-Bankura (2) Dulal Malla (55 Yrs) S/O Lt. Anil Malla of Vill-Patakola PS & Dist-Bankura (3) Ajoy Mal (25 Yrs) S/O Jiten Mal of Vill- Jamboni PS & Dist-Bankura (4) Sujan Mal (29 Yrs) S/O Jiten Mal of Vill-Jamboni PS & Dist-Bankura, during interrogation they admitted before me that they along with some others extracted sand from the Darakeswar river bed near Minapur Maha Samsan since long for clandestine business. On demand, they could not produce any valid documents in respect of such sand. During further interrogation, the said persons admitted that the sand was lifted/ extracted illegally from Darakeswar river bed area by fraudulent means and they used to transport the same elsewhere to sell for their personal wrongful gain. The said persons also failed to provide any satisfactory answer in respect extracting of sand from the Darakeswar river bed and transporting the same to other places. From local enquiry it revealed that the above noted accused persons along with some others have been operating such illegal business by illegal mining/lifting of sand from Minapur Mahasamsan river bed and transporting the same.

During interrogation and local enquiry, I came to learn that the accused persons are operating this illegal sand business in a clandestine manner since long. Accordingly, I, ASI Netai Nandi arrested the accused persons namely (1) Avijit Saha (26 Yrs) S/O Lt. Gopal Saha of Vill-Agaya PS & Dist-Bankura (2) Dulal Malla (55 Yrs) S/O Lt. Anil Malla of Vill-Patakola PS & Dist-Bankura (3) Ajoy Mal (25 Yrs) S/O Jiten Mal of Vill- Jamboni PS & Dist-Bankura (4) Sujan Mal (29 Yrs) S/O Jiten Mal of Vill-Jamboni PS & Dist-Bankura after maintaining all legal formalities prescribed by the Apex Court and NHRC guide line and seized 04 nos. Engine van loaded with 25 sack of sand in each engine van from the PO, under proper seizure list, duly signed by witnesses and also accused persons.

Under this circumstance, I pray that a specific case may kindly be started under proper section of law for proper investigation of this matter.
